- 1 RESIDENTIAL ADDRESS BEFORE THE LICENSE EXPIRES, HE OR SHE SHALL
- 2 REPORT THE CHANGE OF HIS OR HER ADDRESS TO THE SECRETARY OF STATE

- 4 (2) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A PERSON
- 5 WHO REPORTS A CHANGE OF HIS OR HER RESIDENTIAL ADDRESS AND

- 1 (5) THE SECRETARY OF STATE SHALL ESTABLISH AND MAINTAIN A
- 2 STATEWIDE TOLL-FREE TELEPHONE LINE TO IMPLEMENT THIS SECTION.
- 3 (6) -(b)-Failure to have such IF A PERSON FAILS TO REPORT A
- 4 change of HIS OR HER RESIDENTIAL address -recorded as herein pro-
- 5 vided may be cause for revocation or suspension of same
- 6 immediately AND APPLY FOR A CORRECTED OPERATOR'S OR CHAUFFEUR'S
- 7 LICENSE AS REQUIRED UNDER THIS SECTION, HE OR SHE MAY IMMEDIATELY
- 8 HAVE HIS OR HER LICENSE REVOKED OR SUSPENDED if there is no
- 9 response to a notice mailed to his OR HER last known address.
