February 20, 1992, Introduced by Senators WELBORN, DILLINGHAM, CARL and ARTHURHULTZ and referred to the Committee on Family Law, Criminal Law, and Corrections.

A bill to amend Act No. 343 of the Public Acts of 1984, entitled

"An act to define and prohibit the possession or dissemination of obscene material under certain circumstances; to prohibit conduct related thereto; to provide penalties; to prohibit local units of government from enacting or enforcing any law, ordinance, or rule pertaining to matters under this act; and to repeal certain acts and parts of acts,"

being sections 752.361 to 752.374 of the Michigan Compiled Laws, by adding section 8a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 6 HAS DONE 1 OR MORE OF THE FOLLOWING:

- 1 (A) AFFIXED TO THE MATERIAL A PERMANENT LABEL THAT DISPLAYS
- 2 HIS OR HER NAME AND ADDRESS IN LEGIBLE ENGLISH IN 8-POINT TYPE OR
- 3 LARGER.
- 4 (B) STAMPED ON THE MATERIAL IN INDELIBLE INK HIS OR HER NAME
- 5 AND ADDRESS IN LEGIBLE ENGLISH IN 8-POINT TYPE OR LARGER.
- 6 (C) IF THE MATERIAL CANNOT BE LABELED OR STAMPED AS PROVIDED
- 7 IN SUBDIVISION (A) OR (B), PLACED HIS OR HER NAME AND ADDRESS ON
- 8 THE MATERIAL IN SUCH A MANNER THAT WHEN THE MATERIAL IS VIEWED
- 9 HIS OR HER NAME AND ADDRESS WILL APPEAR TO THE VIEWER IN LEGIBLE

- 11 (2) EXCEPT AS PROVIDED IN SUBSECTION (3), A PERSON WHO VIO-
- 12 LATES SUBSECTION (1) IS GUILTY OF A MISDEMEANOR PUNISHABLE BY
- 13 IMPRISONMENT FOR NOT MORE THAN 1 YEAR, OR A FINE OF NOT MORE THAN
- 14 \$500.00, OR BOTH.
- 15 (3) A PERSON WHO COMMITS A SECOND OR SUBSEQUENT VIOLATION OF
- 16 SUBSECTION (1) IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT
- 17 FOR NOT MORE THAN 4 YEARS, OR BY A FINE OF NOT MORE THAN
- 18 \$2,000.00, OR BOTH.
