## SENATE BILL No. 793

March 11, 1992, Introduced by Senators MILLER, CHERRY, HART, O'BRIEN, DINGELL and BERRYMAN and referred to the Committee on Commerce.

A bill to amend section 262 of Act No. 162 of the Public Acts of 1982, entitled

"Nonprofit corporation act,"

as amended by Act No. 37 of the Public Acts of 1991, being section 450.2262 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 262 of Act No. 162 of the Public Acts of
- 2 1982, as amended by Act No. 37 of the Public Acts of 1991, being
- 3 section 450.2262 of the Michigan Compiled Laws, is amended to
- 4 read as follows:
- 5 Sec. 262. (1) An association or society, not otherwise pro-
- 6 vided for here or by other statute, incorporated before
- 7 January 1, 1983, and now existing, whose purpose is to provide
- 8 for the relief of distressed members, visitation of the sick, and
- 9 the payment of a voluntary sick benefit to or for members not

- 1 exceeding \$2,000.00 on account of any 1 member, or the buying and
- 2 selling of products for its members without direct pecuniary
- 3 profit to the association or its members may operate as a corpo-
- 4 ration subject to this act. The ladies Lutheran benevolent fed-
- 5 eration of Michigan, now incorporated as a nonprofit corporation,
- 6 may pay death benefits in an amount not exceeding \$500.00 to any
- 7 1 person. The metropolitan club of America, inc., national
- 8 spirit, and the ladies auxiliary of the metropolitan clubs of
- 9 America, national spirit, which are incorporated as nonprofit
- 10 corporations, may pay death benefits in an amount not to exceed
- 11 \$1,000.00 to any 1 person. The Venetian club of mutual aid,
- 12 incorporated as a nonprofit corporation, may pay death and sick

- 14 The Warren firemen's benevolent association may pay death and

- 8 of eagles within this state may pay death benefits of \$350.00 or
- 9 sickness benefits of \$350.00, but not a combination of death and
- 10 sickness benefits that would exceed \$500.00 to any 1 person.
- 12 before January 1, 1983, and providing for the payment of death or 13 sick benefits under this section in an amount exceeding \$1,000.00 14 to 1 person shall by January 1, 1980, establish and maintain
- 15 reserves in an amount estimated in the aggregate to provide for
- 16 the payment of all losses and claims incurred, whether reported
- 17 or unreported, which are unpaid and for which the entity may be
- 18 liable and to provide for the expense of adjustment or settlement
- 19 of losses and claims. The reserves shall be computed in accord-
- 20 ance with rules promulgated by the commissioner of insurance,
- 21 after due notice and hearing, upon reasonable consideration of
- 22 the ascertained experiences and the character of such kinds of
- 23 business for the purpose of adequately protecting the members and
- 24 securing the solvency of the corporations. The funds of the
- 25 entities securing the reserves shall be invested only in securi-
- 26 ties permitted by the laws of this state for the investment of
- 27 assets of life insurance companies.

1 (3) An entity specified in this section that obligates
2 itself to the payment of death and sick benefits to its members
3 shall not make, issue, or deliver in this state a certificate or
4 other written evidence of the obligation unless the certificate
5 or other written evidence has conspicuously printed on the first
6 page in boldface type not smaller than 10 point the following
7 statement: This organization does not operate under the supervi-

8 sion of the Michigan insurance bureau.
