ENROLLED HOUSE BILL No. 4118

AN ACT to amend sections 3 and 51 of Act No. 152 of the Public Acts of 1979, entitled as amended "An act to provide for the establishment and collection of fees for the regulation of certain occupations and professions, and for certain agencies and businesses; to create certain funds; and to prescribe certain powers and duties of certain state agencies and departments," section 3 as amended by Act No. 268 of the Public Acts of 1990 and section 51 as amended by Act No. 461 of the Public Acts of 1988, being sections 338.2203 and 338.2251 of the Michigan Compiled Laws.

The People of the State of Michigan enact:

Section 1. Sections 3 and 51 of Act No. 152 of the Public Acts of 1979, section 3 as amended by Act No. 268 of the Public Acts of 1990 and section 51 as amended by Act No. 461 of the Public Acts of 1988, being sections 338.2203 and 338.2251 of the Michigan Compiled Laws, are amended to read as follows:

Sec. 3. (1) The fees prescribed by this act shall be used only to offset the cost of operating the department.

(2) Except as otherwise provided in sections 37, 38, and 51, the fees collected pursuant to this act shall be credited to the general fund of the state.

Sec. 51. (1) Fees for a person licensed or seeking licensure to engage in manufacturing, distributing, prescribing, dispensing, or conducting research with controlled substances under part 73 of the public health code, are as follows:

(a) Application processing fee	\$	10.00
(b) License fee, per year		50.00

(2) The official prescription form program fund is established in the state treasury and shall be administered by the department of commerce. Twenty dollars of the license fee received by the department under subsection (1)(b) shall be deposited with the state treasurer to the credit of the official prescription form program fund. The department of commerce shall use the fund only in connection with programs relating to the official prescription forms required under article 7 of the public health code, Act No. 368 of the Public Acts of 1978, being sections 333.7101 to 333.7545 of the Michigan Compiled Laws. Any unexpended balance in the fund at the end of a fiscal year shall carry forward to the next fiscal year.

Section 2. This amendatory act shall not take effect unless House Bill No. 4117 of the 87th Legislature is enacted into law.

This act is ordered to take immediate effect.
