



# HOUSE BILL No. 4061

February 2, 1993, Introduced by Reps. Profit and Freeman and referred to the Committee on Transportation.

A bill to amend Act No. 300 of the Public Acts of 1949, entitled as amended "Michigan vehicle code," as amended, being sections 257.1 to 257.923 of the Michigan Compiled Laws, by adding section 602b.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1 Section 1. Act No. 300 of the Public Acts of 1949, as  
2 amended, being sections 257.1 to 257.923 of the Michigan Compiled  
3 Laws, is amended by adding section 602b to read as follows:

4 SEC. 602B. (1) AN INDIVIDUAL OPERATING A MOTOR VEHICLE ON A  
5 PUBLIC HIGHWAY OR OTHER PLACE GENERALLY ACCESSIBLE TO MOTOR VEHI-  
6 CLES WHO KNOWS OR HAS REASON TO KNOW THAT HE OR SHE HAS BEEN  
7 DIRECTED BY A POLICE OFFICER OR CONSERVATION OFFICER TO STOP THAT

1 MOTOR VEHICLE SHALL STOP THAT MOTOR VEHICLE AS DIRECTED BY THAT  
2 POLICE OR CONSERVATION OFFICER.

3 (2) AN INDIVIDUAL WHO VIOLATES SUBSECTION (1) BY EXCEEDING  
4 THE SPEED LIMIT BY MORE THAN 30 MILES PER HOUR OR OPERATING THAT  
5 MOTOR VEHICLE IN RECKLESS DISREGARD FOR THE SAFETY OF ANY INDI-  
6 VIDUAL IS GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT  
7 MORE THAN 4 YEARS, OR A FINE OF NOT MORE THAN \$2,000.00, OR  
8 BOTH. AN INDIVIDUAL CONVICTED OF A SECOND OR SUBSEQUENT VIOLA-  
9 TION OF THIS SUBSECTION IS GUILTY OF A FELONY AND SHALL BE PUN-  
10 IShed BY IMPRISONMENT FOR NOT LESS THAN 30 DAYS OR MORE THAN 4  
11 YEARS, OR A FINE OF NOT LESS THAN \$500.00 OR MORE THAN \$2,000.00,  
12 OR BOTH. THE COURT SHALL ORDER THE SECRETARY OF STATE TO REVOKE  
13 THE OPERATOR'S LICENSE OR CHAUFFEUR'S LICENSE OF AN INDIVIDUAL  
14 CONVICTED OF VIOLATING THIS SUBSECTION.

15 (3) A MOTOR VEHICLE THAT IS OPERATED IN VIOLATION OF  
16 SUBSECTION (2) IS SUBJECT TO FORFEITURE PURSUANT TO SECTIONS 4701  
17 TO 4709 OF THE REVISED JUDICATURE ACT OF 1961, BEING SECTIONS  
18 600.4701 TO 600.4709 OF THE MICHIGAN COMPILED LAWS.

19 Section 2. This amendatory act shall not take effect unless  
20 all of the following bills of the 87th Legislature are enacted  
21 into law:
