

## **HOUSE BILL No. 4182**

A bill to amend Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code."

as amended, being sections 333.1101 to 333.25211 of the Michigan Compiled Laws, by adding section 21532.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 368 of the Public Acts of 1978, as
- 2 amended, being sections 333.1101 to 333.25211 of the Michigan
- 3 Compiled Laws, is amended by
- 4 SEC. 21532. (1) A HOSPITAL SHALL PROVIDE TO AN UNMARRIED
- 5 MOTHER OF A LIVE CHILD BORN IN THAT HOSPITAL A FORM THAT CAN BE
- 6 COMPLETED BY THE CHILD'S MOTHER AND FATHER TO ACKNOWLEDGE PATER-
- 7 NITY OF THE CHILD. THE HOSPITAL SHALL PROVIDE THE INFORMATION
- 8 DEVELOPED PURSUANT TO SUBSECTION (2) ON THE PURPOSE AND
- 9 COMPLETION OF THE FORM AND ON THE RIGHTS AND RESPONSIBILITIES OF

- 1 THE PARENTS. THE HOSPITAL SHALL PROVIDE THE COMPLETED
- 2 ACKNOWLEDGMENT OF PATERNITY TO THE DEPARTMENT AND TO THE PROBATE
- 3 COURT OF THE MOTHER'S COUNTY OF RESIDENCE FOR RECORDING. THE
- 4 FORM SHALL BE AN AFFIDAVIT THAT, IF PROPERLY COMPLETED AND
- 5 RECORDED WITH THE PROBATE COURT, IS LEGALLY ADMISSIBLE IN COURT
- 6 AS PROOF OF PATERNITY. UPON THE AGENCY'S REQUEST, THE DEPARTMENT
- 7 SHALL MAKE AVAILABLE FOR THE PURPOSE OF CHILD SUPPORT ENFORCEMENT
- 8 AN AFFIDAVIT COMPLETED UNDER THIS SECTION TO THE STATE AGENCY
- 9 AUTHORIZED TO ADMINISTER PART D OF TITLE IV OF THE SOCIAL SECUR-
- 10 ITY ACT, CHAPTER 531, 88 STAT. 2351, 42 U.S.C. 651 TO 669.
- 11 (2) THE DEPARTMENT SHALL DEVELOP AND DISTRIBUTE FREE OF
- 12 CHARGE TO HOSPITALS THE AFFIDAVIT FORM TO ACKNOWLEDGE PATERNITY,
- 13 THE INFORMATION ON THE PURPOSE AND COMPLETION OF THE FORM, AND
- 14 THE INFORMATION ON THE RIGHTS AND RESPONSIBILITIES OF THE PAR-
- 15 ENTS, AND SHALL PROVIDE ASSISTANCE AND TRAINING TO HOSPITAL STAFF
- 16 ASSIGNED RESPONSIBILITY FOR PROVIDING THE INFORMATION. A HOSPI-
- 17 TAL IS IMMUNE FROM CIVIL OR CRIMINAL LIABILITY FOR PROVIDING THE
- 18 FORM, PROVIDING THE INFORMATION DEVELOPED PURSUANT TO THIS SEC-
- 19 TION, OR OTHERWISE FULFILLING ITS DUTIES PURSUANT TO THIS
- 20 SECTION.
- 21 Section 2. This amendatory act shall take effect after the
- 22 expiration of 6 months after the date of its enactment.
