## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Chapter VII of Act No. 175 of the Public Acts of
- 2 1927, as amended, being sections 767.1 to 767.96 of the Michigan
- 3 Compiled Laws, is amended by adding section 94a to read as
- 4 follows:
- CHAPTER VII
- 6 SEC. 94A. EXCEPT AS OTHERWISE PROVIDED BY SUPREME COURT
- 7 RULE, THE DEFENDANT OR HIS OR HER ATTORNEY SHALL DISCLOSE TO THE
- 8 PROSECUTING ATTORNEY UPON REQUEST THE FOLLOWING MATERIAL OR

- 1 INFORMATION WITHIN THE POSSESSION OR CONTROL OF THE DEFENDANT  $O_{\mathbb{R}}$
- 2 HIS OR HER ATTORNEY:
- 3 (A) THE NATURE OF ANY DEFENSE FOR WHICH THE DEFENDANT
- 4 INTENDS TO OFFER EVIDENCE AT TRIAL.
- 5 (B) THE NAME AND LAST KNOWN ADDRESS OF EACH WITNESS OTHER
- 6 THAN THE DEFENDANT WHOM THE DEFENDANT INTENDS TO CALL AT TRIAL
- 7 TOGETHER WITH ANY WRITTEN OR RECORDED STATEMENT OR MEMORANDUM
- 8 THAT SUMMARIZES ANY ORAL STATEMENT MADE BY THAT WITNESS.
- 9 (C) ANY REPORT OR STATEMENT BY AN EXPERT CONCERNING A MENTAL
- 10 OR PHYSICAL EXAMINATION, OR ANY OTHER TEST, EXPERIMENT, OR COM-
- 11 PARISON THAT THE DEFENDANT INTENDS TO OFFER IN EVIDENCE, OR THAT
- 12 WAS PREPARED BY A PERSON WHOM THE DEFENDANT INTENDS TO CALL AS A
- 13 WITNESS, IF THE REPORT OR STATEMENT RELATES TO THE TESTIMONY TO
- 14 BE OFFERED.
- 15 (D) ANY BOOK, PAPER, DOCUMENT, PHOTOGRAPH, OR TANGIBLE
- 16 OBJECT THAT THE DEFENDANT INTENDS TO OFFER IN EVIDENCE OR THAT
- 17 RELATES TO THE TESTIMONY OF A WITNESS WHOM THE DEFENDANT INTENDS
- 18 TO CALL.
