THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 206 of the Public Acts of 1893, as
- 2 amended, being sections 211.1 to 211.157 of the Michigan Compiled
- 3 Laws, is amended by adding section 2b to read as follows:
- 4 SEC. 2B. BEGINNING DECEMBER 31, 1992, ALL PROPERTY CLASSI-
- 5 FIED AS RESIDENTIAL OR AGRICULTURAL UNDER SECTION 34C IS EXEMPT
- 6 FROM MILLAGE LEVIED FOR LOCAL SCHOOL DISTRICT OPERATING
- 7 PURPOSES. BEGINNING DECEMBER 31, 1992, ALL PROPERTY OTHER THAN
- 8 PROPERTY CLASSIFIED AS RESIDENTIAL OR AGRICULTURAL UNDER
