THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 62 of the Public Acts of 1933, as
- 2 amended, being sections 211.201 to 211.217a of the Michigan
- 3 Compiled Laws, is amended by adding section 18 to read as
- 4 follows:
- 5 SEC. 18. A COUNTY SHALL NOT ALLOCATE FEWER MILLS TO A LOCAL
- 6 SCHOOL DISTRICT THAN THE NUMBER OF MILLS ALLOCATED TO THAT SCHOOL
- 7 DISTRICT IN 1993.
