



HOUSE BILL No. 4289

February 17, 1993, Introduced by Reps. Bandstra, Jamian, Horton, Jaye, Bodem, McNutt, Hammerstrom, Gustafson and Crissman and referred to the Committee on Judiciary.

A bill to amend section 2507 of Act No. 236 of the Public Acts of 1961, entitled as amended

"Revised judicature act of 1961,"

being section 600.2507 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 2507 of Act No. 236 of the Public Acts
2 of 1961, being section 600.2507 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 2507. (1) The secretary of state, THE auditor general,
5 THE STATE treasurer, and THE attorney general ~~—, respectively,~~

8 (2) THE DIRECTOR OF COMMERCE MAY REQUEST SEARCHES AND OBTAIN
9 CERTIFIED COPIES AND CERTIFIED EXTRACTS OF PAPERS, RECORDS, OR
10 DOCUMENTS PERTAINING TO CRIMINAL MATTERS, MEDICAL MALPRACTICE, OR
11 OTHER PUBLIC DOCUMENTS OR RECORDS NECESSARY TO THE DISCHARGE OF
12 THE DUTIES OF THE BUREAU WITHIN THE DEPARTMENT OF COMMERCE WITH
13 RESPONSIBILITY FOR OCCUPATIONAL AND PROFESSIONAL LICENSURE FROM
14 THE SECRETARY OF STATE, THE AUDITOR GENERAL, THE STATE TREASURER,
15 THE CLERK OF ANY COURT OF RECORD OR MUNICIPAL COURT, OR FROM THE
16 OFFICE OF A REGISTER OF DEEDS. THE SECRETARY OF STATE, THE AUDI-
17 TOR GENERAL, THE STATE TREASURER, THE CLERK OF ANY COURT OF
18 RECORD OR MUNICIPAL COURT, OR THE OFFICE OF A REGISTER OF DEEDS
19 MAY CHARGE A REASONABLE FEE FOR PROVIDING THE REQUESTED INFORMA-
20 TION UNDER THIS SUBSECTION, NOT TO EXCEED THE ACTUAL COST FOR
21 PROVIDING THE REQUESTED INFORMATION.
