

HOUSE BILL No. 4412

March 2, 1993, Introduced by Reps. Sikkema, Rivers, Freeman, Middleton and Pitoniak and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend Act No. 348 of the Public Acts of 1965, entitled as amended

"Air pollution act,"

as amended, being sections 336.11 to 336.36 of the Michigan Compiled Laws, by adding section 5b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 348 of the Public Acts of 1965, as
- 2 amended, being sections 336.11 to 336.36 of the Michigan Compiled
- 3 Laws, is amended by adding section 5b to read as follows:
- 4 SEC. 5B. (1) IN ADDITION TO OR IN CONJUNCTION WITH ANY
- 5 OTHER TESTING REQUIREMENTS PROVIDED IN THIS ACT, A RULE PROMUL-
- 6 GATED UNDER THIS ACT, OR A PERMIT ISSUED UNDER THIS ACT, THE
- 7 OWNER OR OPERATOR OF A MUNICIPAL SOLID WASTE INCINERATOR SHALL
- 8 ANNUALLY CONDUCT EMISSION TESTING ON EACH EMITTING UNIT OF THE

- 1 MUNICIPAL SOLID WASTE INCINERATOR, IN A MANNER APPROVED BY THE
- 2 COMMISSION, FOR EACH OF THE FOLLOWING:
- 3 (A) PARTICULATE MATTER.
- 4 (B) MERCURY.
- 5 (C) CADMIUM.
- 6 (D) HEXAVALENT CHROMIUM.
- 7 (E) LEAD.
- 8 (F) ARSENIC.
- 9 (G) CHLORINATED DIBENZO-P-DIOXINS.
- 10 (H) CHLORINATED DIBENZOFURANS.
- 11 (I) HYDROGEN CHLORIDE.
- 12 (J) SULFUR DIOXIDE.
- 13 (K) CARBON MONOXIDE.
- 14 (1) NITROGEN OXIDES.
- 15 (2) THE RESULTS OF THE EMISSION TESTING REQUIRED UNDER SUB-
- 16 SECTION (1) SHALL BE REPORTED TO THE DEPARTMENT OF NATURAL
- 17 RESOURCES WITHIN 90 DAYS OF CONDUCTING THE TEST. THE EMISSIONS
- 18 OF EACH AIR CONTAMINANT LISTED IN SUBSECTION (1) SHALL BE
- 19 REPORTED NUMERICALLY IN EACH OF THE FOLLOWING TERMS:
- 20 (A) AVERAGE HOURLY CONCENTRATION.
- 21 (B) POUNDS PER HOUR.
- 22 (C) MAXIMUM TOTAL POUNDS PER YEAR.
- 23 (3) THE DEPARTMENT OF NATURAL RESOURCES SHALL ANNUALLY PUB-
- 24 LISH AND SUBMIT BY OCTOBER 1 OF EACH CALENDAR YEAR TO THE LEGIS-
- 25 LATURE A REPORT THAT CONTAINS A LIST OF ALL MUNICIPAL SOLID WASTE
- 26 INCINERATORS AND THE RESULTS OF THE EMISSIONS TESTS CONDUCTED

- 1 PURSUANT TO THIS SECTION FOR EACH MUNICIPAL SOLID WASTE
- 2 INCINERATOR.
- 3 (4) AS USED IN THIS SECTION, "MUNICIPAL SOLID WASTE
- 4 INCINERATOR" MEANS A MUNICIPAL SOLID WASTE INCINERATOR AS DEFINED
- 5 IN SECTION 5 OF THE SOLID WASTE MANAGEMENT ACT, ACT NO. 641 OF
- 6 THE PUBLIC ACTS OF 1978, BEING SECTION 299.405 OF THE MICHIGAN
- 7 COMPILED LAWS, THAT INCINERATES GREATER THAN 50 TONS OF SOLID
- 8 WASTE PER DAY.
- 9 (5) THIS SECTION SHALL TAKE EFFECT JANUARY 1, 1994.
