- 1 VIOLATION OF SECTION 145C, 520B, 520C, 520D, 520E, OR 520G OF THE

- 2 in which the alleged victim was less than 18 years of age when
- 3 the offense was committed, the Legislature intends the extension
- 4 of the limitations period for the prosecution of those violations
- 5 created by this amendatory act to apply retroactively to those
- 6 offenses for which prosecution is not barred at the effective
- 7 date of this amendatory act.
