THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. The title of Act No. 451 of the Public Acts of
- 2 1976, as amended, being sections 380.1 to 380.1852 of the
- 3 Michigan Compiled Laws, is amended and section 1287a is added to
- 4 read as follows:
- 5 TITLE
- 6 An act to provide a system of public instruction and elemen-
- 7 tary and secondary schools; to revise, consolidate, and classify
- 8 the laws relating to elementary and secondary education; to
- 9 provide for the classification, organization, regulation, and

1 maintenance of schools, school districts, and intermediate school 2 districts; to prescribe rights, powers, duties, and privileges of 3 schools, school districts, and intermediate school districts; to 4 provide for the regulation of school teachers and school adminis-5 trators; to provide for school elections and to prescribe powers 6 and duties with respect thereto; to provide for the levy and col-7 lection of taxes; to provide for the borrowing of money and issu-8 ance of bonds and other evidences of indebtedness; to establish a 9 fund and provide for expenditures from that fund; to provide for 10 and prescribe the powers and duties of certain state departments, 11 the state board of education, and certain other boards and offi-12 cials: TO CREATE A STATEWIDE CABINET ON PROFESSIONAL AND TECHNI-13 CAL STANDARDS WITHIN THE LEGISLATIVE COUNCIL AND PRESCRIBE ITS 14 DUTIES; to provide for licensure of boarding schools; to pre-15 scribe penalties; and to repeal certain acts and parts of acts. SEC. 1287A. (1) THE STATEWIDE CABINET FOR PROFESSIONAL AND 17 TECHNICAL STANDARDS IS CREATED WITHIN THE LEGISLATIVE COUNCIL TO 18 DEVELOP AND OVERSEE A STATEWIDE PLAN FOR GATHERING, DISSEMINAT-19 ING, AND PROVIDING ACCURATE INFORMATION ON EMPLOYMENT AND 20 SKILL-LEVEL NEEDS IN THE WORKPLACE AND TO ENGAGE IN RELATED THE CABINET SHALL CONSIST OF 15 MEMBERS AS FOLLOWS: 21 ACTIVITIES. (A) NOT LATER THAN JANUARY 1, 1994, BASED ON NOMINATIONS 22 23 SUBMITTED BY ORGANIZATIONS REPRESENTING THE BUSINESS COMMUNITY, 24 THE EDUCATION COMMUNITY, AND ORGANIZED LABOR, THE GOVERNOR, THE 25 SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND THE SENATE MAJORITY 26 LEADER SHALL EACH APPOINT 3 MEMBERS, 1 REPRESENTING BUSINESS, 1 27 REPRESENTING EDUCATION, AND 1 REPRESENTING ORGANIZED LABOR.

- 1 GOVERNOR, SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND THE SENATE
- 2 MAJORITY LEADER SHALL CONFER TO ENSURE THAT AT LEAST 1 OF THE
- 3 MEMBERS APPOINTED TO REPRESENT EDUCATION IS A CERTIFICATED
- 4 TEACHER.
- 5 (B) NOT LATER THAN JANUARY 1, 1994, BASED ON NOMINATIONS
- 6 SUBMITTED BY ORGANIZATIONS REPRESENTING VOCATIONAL EDUCATION, THE
- 7 GOVERNOR, THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, AND THE
- 8 SENATE MAJORITY LEADER JOINTLY SHALL APPOINT 1 MEMBER TO REPRE-
- 9 SENT VOCATIONAL EDUCATION. IF THE GOVERNOR, SPEAKER OF THE HOUSE
- 10 OF REPRESENTATIVES, AND SENATE MAJORITY LEADER DO NOT AGREE ON A
- 11 JOINT APPOINTEE UNDER THIS SUBDIVISION, 2 OF THE 3 MAY JOINTLY
- 12 MAKE THE APPOINTMENT.
- 13 (C) EACH OF THE FOLLOWING SHALL SERVE AS A MEMBER:
- (i) ONE MEMBER OF THE STATE BOARD OF EDUCATION, AS DESIG-
- 15 NATED BY THE STATE BOARD.
- 16 (ii) THE SUPERINTENDENT OF PUBLIC INSTRUCTION OR HIS OR HER
- 17 DESIGNEE.
- 18 (iii) THE DIRECTOR OF LABOR OR HIS OR HER DESIGNEE.
- 19 (iv) THE DIRECTOR OF COMMERCE OR HIS OR HER DESIGNEE.
- 20 (v) THE GOVERNOR'S ADVISER ON JOB TRAINING OR HIS OR HER
- 21 DESIGNEE.
- 22 (2) MEMBERS OF THE CABINET APPOINTED UNDER SUBSECTION (1)(A)
- 23 OR (B) SHALL SERVE FOR TERMS OF 3 YEARS, EXCEPT THAT OF THE MEM-
- 24 BERS INITIALLY APPOINTED TO THE CABINET UNDER SUBSECTION (1)(A),
- 25 3 SHALL SERVE FOR 5 YEARS, 3 SHALL SERVE FOR 4 YEARS, AND 3 SHALL
- 26 SERVE FOR 3 YEARS. THE GOVERNOR, THE SPEAKER OF THE HOUSE OF
- 27 REPRESENTATIVES, AND THE SENATE MAJORITY LEADER SHALL CONFER AND

- 1 AGREE ON AN INITIAL APPOINTMENT SCHEDULE THAT ENSURES THAT THE
- 2 TERM OF NOT MORE THAN 1 OF THE REPRESENTATIVES FROM EACH OF THE 3
- 3 GROUPS DESCRIBED IN SUBSECTION (1)(A) EXPIRES EACH YEAR. A
- 4 VACANCY SHALL BE FILLED IN THE SAME MANNER AS THE ORIGINAL
- 5 APPOINTMENT.
- 6 (3) THE GOVERNOR, THE SPEAKER OF THE HOUSE OF REPRESENTA-
- 7 TIVES, AND THE SENATE MAJORITY LEADER JOINTLY SHALL APPOINT 1 OF
- 8 THE MEMBERS OF THE CABINET TO SERVE FOR A 3-YEAR TERM AS THE INI-
- 9 TIAL CHAIRPERSON OF THE CABINET. IF THE GOVERNOR, SPEAKER OF THE
- 10 HOUSE OF REPRESENTATIVES, AND SENATE MAJORITY LEADER DO NOT AGREE
- 11 ON A JOINT APPOINTEE AS THE INITIAL CHAIRPERSON, 2 OF THE 3 MAY
- 12 JOINTLY MAKE THE APPOINTMENT. AFTER THE EXPIRATION OF THE TERM
- 13 OF THE INITIAL CHAIRPERSON, THE CABINET, BY A MAJORITY VOTE OF
- 14 THE MEMBERS SERVING, ANNUALLY SHALL SELECT A MEMBER TO SERVE AS
- 15 CHAIRPERSON. A VACANCY IN THE OFFICE OF CHAIRPERSON OF THE CABI-
- 16 NET SHALL BE FILLED FOR THE BALANCE OF THE UNEXPIRED TERM BY A
- 17 MAJORITY VOTE OF THE MEMBERS APPOINTED AND SERVING.
- 18 (4) THE CABINET, BY A MAJORITY VOTE OF THE MEMBERS SERVING,
- 19 ANNUALLY SHALL SELECT A MEMBER TO SERVE AS VICE-CHAIRPERSON AND A
- 20 MEMBER TO SERVE AS SECRETARY. A VACANCY IN EITHER OF THOSE
- 21 OFFICES SHALL BE FILLED FOR THE BALANCE OF THE UNEXPIRED TERM BY
- 22 A MAJORITY VOTE OF THE MEMBERS APPOINTED AND SERVING.
- 23 (5) THE CABINET, BY A MAJORITY VOTE OF THE MEMBERS SERVING,
- 24 SHALL ADOPT BYLAWS AS ARE APPROPRIATE AND NECESSARY TO CARRY OUT
- 25 THE CABINET'S RESPONSIBILITIES.
- 26 (6) THE LEGISLATIVE COUNCIL SHALL PROVIDE THE CABINET WITH
- 27 SUFFICIENT STAFF TO CARRY OUT THE CABINET'S RESPONSIBILITIES.

- 1 (7) A MEMBER OF THE CABINET SHALL NOT BE PAID A SALARY FOR
- 2 SERVING ON THE CABINET, BUT EACH MEMBER MAY RECEIVE REIMBURSEMENT
- 3 FOR ACTUAL AND NECESSARY TRAVEL AND OTHER EXPENSES INCURRED IN
- A THE PERFORMANCE OF OFFICIAL DUTIES.
- 5 (8) NOT LATER THAN JANUARY 1, 1995, THE CABINET SHALL
- 6 DEVELOP AND SUBMIT TO THE LEGISLATURE, THE GOVERNOR, AND THE
- 7 STATE BOARD A STATEWIDE PLAN FOR GATHERING AND DISSEMINATING
- 8 ACCURATE INFORMATION ON CURRENT AND ANTICIPATED EMPLOYMENT NEEDS,
- 9 FOR DETERMINING THE TYPE AND LEVEL OF SKILLS AND EDUCATION THAT
- 10 WILL BE REQUIRED FOR EMPLOYMENT, AND FOR HELPING LOCAL AND INTER-
- 11 MEDIATE SCHOOL DISTRICTS ALTER, EXPAND, AND IMPROVE EXISTING EDU-
- 12 CATIONAL PROGRAMS TO MEET FUTURE EMPLOYMENT NEEDS, AND RECOM-
- 13 MENDED LEGISLATION FOR IMPLEMENTING THE PLAN. TO THE EXTENT POS-
- 14 SIBLE, THE PLAN SHALL PROVIDE FOR THE USE OF EXISTING RESOURCES
- 15 OF AND INFORMATION ALREADY GATHERED BY EXISTING AGENCIES, ORGANI-
- 16 ZATIONS, COUNCILS, AND COMMITTEES THAT HAVE BEEN ESTABLISHED BY
- 17 LAW AND THAT HAVE A PRIMARY FUNCTION DIRECTLY RELATED TO EDUCA-
- 18 TION, EMPLOYMENT, OR JOB TRAINING. THE PLAN OR RECOMMENDATIONS
- 19 FOR LEGISLATION, AS APPROPRIATE, SHALL INCLUDE AT LEAST ALL OF
- 20 THE FOLLOWING:
- 21 (A) CRITERIA AND METHODS FOR ESTABLISHING A NEW STATEWIDE
- 22 LABOR MARKET INFORMATION EXCHANGE SYSTEM, TO BE COMPRISED OF
- 23 SELF-GOVERNING STATE AND LOCAL OCCUPATIONAL COUNCILS, AS
- 24 FOLLOWS:
- 25 (i) A STATE OCCUPATIONAL COUNCIL FOR EACH MAJOR OCCUPATIONAL
- 26 AREA IN THE STATE. EACH STATE OCCUPATIONAL COUNCIL SHALL BE
- 27 COMPOSED OF INDIVIDUALS REPRESENTATIVE OF THE MAJOR OCCUPATIONAL

- 1 AREA FOR WHICH THE COUNCIL IS CREATED AND SHALL BE RESPONSIBLE
- 2 FOR PROVIDING INFORMATION ON CURRENT AND ANTICIPATED EMPLOYMENT
- 3 NEEDS THROUGHOUT THE STATE IN THE OCCUPATIONAL AREA, INCLUDING
- 4 THE EDUCATION AND SKILLS THAT WILL BE REQUIRED, AND FOR DEVELOP-
- 5 ING A UNIFORM STANDARD OF COMPETENCY FOR THE OCCUPATIONAL AREA.
- 6 WITH RESPECT TO THE STATE OCCUPATIONAL COUNCILS, THE PLAN SHALL
- 7 INCLUDE AT LEAST RECOMMENDED CRITERIA FOR DETERMINING THE MAJOR
- 8 OCCUPATIONAL AREAS FOR WHICH A STATE OCCUPATIONAL COUNCIL SHALL
- 9 BE ESTABLISHED, ENSURING THAT THERE IS A SUFFICIENT NUMBER OF
- 10 STATE OCCUPATIONAL COUNCILS SO THAT EACH MAJOR OCCUPATIONAL AREA
- 11 OR CLUSTER OF OCCUPATIONAL AREAS IS REPRESENTED BY A COUNCIL;
- 12 RECOMMENDED NUMBER, METHOD FOR SELECTION OR APPOINTMENT, AND
- 13 LENGTH OF TERM OF MEMBERS OF A STATE OCCUPATIONAL COUNCIL; AND
- 14 RECOMMENDED RESPONSIBILITY TO BE GIVEN TO A STATE OCCUPATIONAL
- 15 COUNCIL AND PROCEDURES AND TIMELINES UNDER WHICH A COUNCIL WOULD
- 16 BE EXPECTED TO OPERATE.
- 17 (ii) LOCAL OCCUPATIONAL COUNCILS TO SERVE PARTICULAR GEO-
- 18 GRAPHIC AREAS. EACH LOCAL OCCUPATIONAL COUNCIL SHALL BE RESPON-
- 19 SIBLE FOR ASSESSING AND PROVIDING INFORMATION ON LOCAL AND
- 20 REGIONAL EMPLOYMENT NEEDS IN THE AREA SERVED BY THE COUNCIL AND
- 21 ASSISTING LOCAL AND INTERMEDIATE SCHOOL DISTRICTS TO IMPLEMENT
- 22 NEEDED CHANGES. IF POSSIBLE, AN EXISTING AGENCY, ORGANIZATION,
- 23 COUNCIL, OR COMMITTEE THAT HAS BEEN ESTABLISHED BY LAW IN THE
- 24 AREA TO BE SERVED BY A LOCAL OCCUPATIONAL COUNCIL AND THAT HAS A
- 25 PRIMARY FUNCTION DIRECTLY RELATED TO EDUCATION, EMPLOYMENT, OR
- 26 JOB TRAINING SHALL BE USED IN STRUCTURING THE LOCAL OCCUPATIONAL
- 27 COUNCIL. WITH RESPECT TO THE LOCAL OCCUPATIONAL COUNCILS, THE

- 1 PLAN SHALL INCLUDE AT LEAST THE RECOMMENDED CRITERIA FOR
- 2 DETERMINING THE NUMBER OF LOCAL OCCUPATIONAL COUNCILS NEEDED
- 3 ACROSS THE STATE AND WHETHER THE COUNCILS SHOULD BE CONFIGURED TO
- 4 SERVE THE AREAS REPRESENTED BY EXISTING LOCAL OR INTERMEDIATE
- 5 SCHOOL DISTRICTS; RECOMMENDATIONS ON THE TYPES OF INDIVIDUALS TO
- 6 SERVE ON A LOCAL OCCUPATIONAL COUNCIL; AND RECOMMENDED NUMBER,
- 7 METHOD FOR SELECTION OR APPOINTMENT, AND LENGTH OF TERM OF MEM-
- 8 BERS OF A LOCAL OCCUPATIONAL COUNCIL.
- 9 (B) CRITERIA AND METHODS FOR DETERMINING THE COMPETENCIES,
- 10 SKILLS AND SKILL LEVELS, AND KNOWLEDGE, INCLUDING EMPLOYABILITY
- 11 AND PROBLEM SOLVING SKILLS, THAT WILL BE NEEDED IN THE WORKPLACE,
- 12 BASED ON RECOMMENDATIONS MADE BY THE STATE OCCUPATIONAL
- 13 COUNCILS. THE COMPETENCIES SHALL INCLUDE AT LEAST UNDERSTANDING
- 14 AND APPLYING TECHNICAL INSTRUCTIONS, APPLIED PHYSICS, AND STATIS-
- 15 TICAL ANALYSIS.
- (C) CRITERIA AND METHODS FOR EVALUATING WHETHER EXISTING
- 17 CURRICULA AND PROGRAMS, BASED ON THE MODEL CORE CURRICULUM
- 18 REQUIREMENTS OUTLINED UNDER SECTION 1278, ARE REFLECTIVE OF THE
- 19 NEEDED COMPETENCIES, SKILLS AND SKILL LEVELS, AND KNOWLEDGE,
- 20 INCLUDING EMPLOYABILITY AND PROBLEM SOLVING SKILLS, AND FOR EVAL-
- 21 UATING WHETHER THE EXISTING SCHOOL YEAR SHOULD BE LENGTHENED OR
- 22 OTHERWISE ALTERED AND WHETHER THE MANDATORY SCHOOL ATTENDANCE AGE
- 23 SHOULD BE RAISED. IT IS INTENDED THAT THIS EVALUATION WILL BE
- 24 USED FOR MODIFYING OR EXPANDING CURRICULA AND PROGRAMS AND FOR
- 25 MAKING OTHER LEGISLATIVE CHANGES IF IT IS DETERMINED THAT CHANGES
- 26 ARE NECESSARY.

- 1 (D) CRITERIA AND METHODS FOR ESTABLISHING THE MECHANISMS
- 2 THAT MAY BE UTILIZED IN ASSESSING WHETHER PUPILS HAVE ATTAINED
- 3 THE EXPECTED COMPETENCIES, SKILLS AND SKILL LEVELS, AND KNOWL-
- 4 EDGE, INCLUDING EMPLOYABILITY AND PROBLEM SOLVING SKILLS. IT IS
- 5 INTENDED THAT EXPERTS IN THAT TYPE OF MEASUREMENT AND ASSESSMENT
- 6 WILL BE USED IN ESTABLISHING ASSESSMENT MECHANISMS UNDER THIS
- 7 SUBDIVISION.
- 8 (E) CRITERIA FOR DEVELOPING AND COORDINATING YOUTH APPREN-
- 9 TICESHIP, INTERNSHIP, AND COOPERATIVE EDUCATIONAL PROGRAMS IN THE
- 10 PRIVATE SECTOR WORK SETTING.
- 11 (F) CRITERIA AND METHODS FOR IDENTIFYING THE WAYS IN WHICH
- 12 EXISTING REVENUE IS BEING USED TO TRAIN AND EDUCATE INDIVIDUALS
- 13 FOR THE WORKPLACE, INCLUDING STATE, FEDERAL, AND PRIVATE
- 14 RESOURCES, AND RECOMMENDATIONS ON A MORE EFFICIENT AND EFFECTIVE
- 15 USE OF THOSE FUNDS, WHETHER ADDITIONAL FUNDING IS NEEDED, AND THE
- 16 PURPOSE OF ADDITIONAL FUNDING.
- 17 (G) CRITERIA AND METHODS FOR ANALYZING THE EDUCATIONAL
- 18 EXPECTATIONS OF COMMUNITY COLLEGES AND OTHER INSTITUTIONS OF
- 19 HIGHER EDUCATION AND RECOMMENDATIONS PERTAINING TO THE ROLE EACH
- 20 OF THEM SHOULD PLAY IN HELPING TO PROVIDE STUDENTS WITH A TOTAL
- 21 EDUCATIONAL SYSTEM AND A SEAMLESS TRANSITION FROM HIGH SCHOOL TO
- 22 COLLEGE OR WORK.
- 23 (H) CRITERIA AND METHODS FOR DETERMINING HOW THE CABINET
- 24 WILL PROVIDE ONGOING OVERSIGHT OVER THE LABOR MARKET INFORMATION
- 25 EXCHANGE SYSTEM AND THE STATE AND LOCAL OCCUPATIONAL COUNCILS,
- 26 INCLUDING COORDINATING, MONITORING, AND MODIFYING THE PLAN AS
- 27 NECESSARY.

- (I) METHODS FOR BUSINESS TO WORK COOPERATIVELY WITH SCHOOLS
- 2 AND OTHER EDUCATIONAL INSTITUTIONS TO DEVELOP SCHOOL-TO-WORK
- 3 STRATEGIES, INCLUDING PROVIDING ON-THE-JOB TRAINING AND EMPLOY-
- 4 MENT ORIENTATION FOR STUDENTS WISHING TO PURSUE AREAS OF STUDY
- 5 RELATED TO PARTICULAR EMPLOYMENT.
- 6 (J) METHODS FOR BUSINESS AND HIGHER EDUCATION TO ASSIST IN
- 7 THE EFFORT TO PROVIDE WORK-BASED EDUCATION BY DEVELOPING MODELS
- 8 FOR YOUTH APPRENTICESHIP PROGRAMS THAT CAN BE APPLIED TO A VARI-
- 9 ETY OF OCCUPATIONAL AREAS, AND THE APPROPRIATE CURRICULA TO COM-
- 10 PLEMENT THIS LEARNING. THE NEW MODELS SHALL EMPHASIZE CAREER
- 11 AREAS RATHER THAN SPECIFIC JOBS SO THAT YOUTH APPRENTICES ARE
- 12 EXPOSED TO A VARIETY OF OCCUPATIONS WITHIN A CAREER AREA. IN ALL
- 13 INSTANCES, THE FOCUS SHALL BE ON PROVIDING STUDENTS WITH BROAD
- 14 AND WIDELY APPLICABLE KNOWLEDGE AND JOB SKILLS. THE ASPECTS OF
- 15 TRADITIONAL APPRENTICESHIP THAT CAN BE APPLIED TO YOUTH APPREN-
- 16 TICESHIP INCLUDE, BUT ARE NOT LIMITED TO, ALL OF THE FOLLOWING:
- (i) THE BASIC FORMAT OF STRUCTURED ON-THE-JOB TRAINING COM-
- 18 BINED WITH CLASSROOM OR THEORETICAL INSTRUCTION.
- 19 (ii) FORMAL RECOGNITION, SUCH AS ACCREDITATION, AFFORDED
- 20 PROGRAMS, AND THE AWARDING OF WORKER CREDENTIALS UPON
- 21 COMPLETION.
- 22 (iii) THE TRANSFER OF SKILLS ON THE JOB THROUGH A MENTOR OR
- 23 SKILLED SUPERVISOR.
- 24 (iv) THE OPPORTUNITY FOR THE TRAINEE TO ACQUIRE SKILLS WHILE
- 25 EARNING A WAGE.
- 26 (v) A CONTRACT OR AGREEMENT BETWEEN THE TRAINING SPONSOR AND
- 27 THE TRAINEE ON THE PROCESS AND OUTCOMES OF TRAINING.

- 1 (K) METHODS FOR BUSINESS TO INVEST IN THE EDUCATIONAL SYSTEM
- 2 BY ASSISTING IN ONGOING TEACHER TRAINING, PROVIDING EQUIPMENT,
- 3 AND FURNISHING ONGOING INFORMATION ON THE CHANGES THAT OCCUR IN
- 4 THE WORKPLACE.
- 5 (1) METHODS FOR ENCOURAGING COMMUNITY COLLEGES, PROPRIETARY
- 6 SCHOOLS, AND COLLEGES AND UNIVERSITIES TO PROVIDE ADVANCED PLACE-
- 7 MENT FOR STUDENTS SUCCESSFULLY COMPLETING AN APPLIED ACADEMIC
- 8 AREA OF STUDY, BY TAKING INTO ACCOUNT THE CREDITS EARNED AND
- 9 SKILLS MASTERED FROM THAT STUDY.
- 10 (M) METHODS FOR COMMUNITY COLLEGES, COLLEGES, AND UNIVERSI-
- 11 TIES TO COLLABORATE WITH LOCAL AND INTERMEDIATE SCHOOL DISTRICTS
- 12 TO MAKE EQUIPMENT, LABORATORIES, AND SUPPLIES AVAILABLE TO THE
- 13 DISTRICTS IF IT IS MORE COST EFFECTIVE THAN ACQUISITION BY THE
- 14 DISTRICTS.

- 17 NICAL STANDARDS SHALL CONTINUE TO MONITOR EMPLOYMENT NEEDS AND
- 18 ANNUALLY SHALL UPDATE THE PLAN AND RECOMMENDATIONS FOR LEGISLA-
- 19 TION AS NECESSARY TO MEET CHANGING NEEDS AND SHALL SUBMIT THE
- 20 UPDATE TO THE LEGISLATURE, THE GOVERNOR, AND THE STATE BOARD.
- 21 (10) IN ADDITION TO ITS OTHER DUTIES, THE STATEWIDE CABINET
- 22 FOR PROFESSIONAL AND TECHNICAL STANDARDS SHALL MAKE RECOMMENDA-

- 13 NESS, BEFORE BEING PERMITTED TO ADVANCE TO HIGHER LEVELS OF

- 15 (ii) THAT PUPILS ARE PERMITTED TO WORK AT THEIR OWN PACE.
- 16 (iii) THAT, RATHER THAN GRADE-LEVEL PROMOTIONS, PUPILS ARE
- 17 ADVANCED TO HIGHER LEVELS BASED UPON SUCCESSFULLY MASTERING INDI-
- 18 VIDUAL SUBJECT AREAS AND SKILLS.
- 19 (iv) THAT ASSESSMENTS ARE OUTCOME-BASED AND REFLECTIVE OF
- 20 NECESSARY COMPETENCIES, SKILLS AND SKILL LEVELS, AND KNOWLEDGE
- 21 IDENTIFIED BY THE STATEWIDE CABINET FOR PROFESSIONAL AND TECHNI-
- 22 CAL STANDARDS AND THE STATE OCCUPATIONAL COUNCILS.
- 23 (v) THAT ANY PUPIL WHO IS UNABLE TO SUCCESSFULLY DEMONSTRATE
- 24 A MASTERY OF THE BASIC SKILLS, COMPETENCIES, OR KNOWLEDGE IN A
- 25 GIVEN SUBJECT AREA WILL BE PROVIDED WITH ADDITIONAL SUPPORT AND
- 26 HELP UNTIL THE PUPIL IS ABLE TO MEET THE REQUIRED COMPETENCIES IN
- 27 THE SUBJECT AREA.

- 1 (C) THAT, REGARDLESS OF AGE, A PUPIL ACHIEVING THE DEFINED
- 2 COMPETENCIES IN BASIC SKILL AREAS SHALL BE AWARDED A CERTIFICATE
- 3 OF INITIAL MASTERY AND A PUPIL ACHIEVING HIGHER SKILL-LEVEL
- 4 ATTAINMENT SHALL BE PROVIDED A CERTIFICATE OF ADVANCED MASTERY IN
- 5 RECOGNITION THAT HE OR SHE HAS ACHIEVED THE EXPECTED OUTCOMES.

- 9 (i) NOT LATER THAN DURING MIDDLE SCHOOL EDUCATION, ONGOING
- 10 COMPREHENSIVE AND ACCURATE INFORMATION AND COUNSELING ABOUT
- 11 EMPLOYMENT OPPORTUNITIES LIKELY TO BE AVAILABLE TO THE PUPIL AND
- 12 THE SKILLS NEEDED TO TAKE ADVANTAGE OF THE OPPORTUNITIES.
- 13 (ii) UPON ENTERING HIGH SCHOOL, BASED UPON THE ANTICIPATED
- 14 NEEDS OF BUSINESS IDENTIFIED BY THE STATEWIDE CABINET FOR PROFES-
- 15 SIONAL AND TECHNICAL STANDARDS, THE OPPORTUNITY TO PURSUE A WIDE
- 16 RANGE OF CAREER/TECHNICAL PROGRAMS DESIGNED TO PROVIDE THE PUPIL
- 17 WITH THE SKILLS AND QUALIFICATIONS NEEDED TO BECOME EMPLOYED OR
- 18 OBTAIN ADDITIONAL EDUCATION AND TRAINING.
- 19 (iii) IN HIGH SCHOOL, A COMPREHENSIVE, WORK-SITE BASED EDU-
- 20 CATION, INCLUDING YOUTH APPRENTICESHIPS, INTERNSHIPS, AND COOPER-
- 21 ATIVE EDUCATION PROGRAMMING IN A WIDE RANGE OF OCCUPATIONAL
- 22 FIELDS, COMPLEMENTED WITH RELATED AND ADVANCED SUBJECT AREA STUDY
- 23 IN THE CLASSROOM.
- 24 (E) THAT, BASED ON THE WORK-RELATED SKILLS AND EDUCATION
- 25 REQUIREMENTS IDENTIFIED BY THE STATEWIDE CABINET FOR PROFESSIONAL
- 26 AND TECHNICAL STANDARDS, STUDENTS WHO SUCCESSFULLY COMPLETE A
- 27 FULL APPLIED ACADEMIC AREA OF STUDY SHALL BE PROVIDED WITH A

- 1 CERTIFICATE OF ACHIEVEMENT RECOGNIZED BY BUSINESS AS AN
- 2 INDICATION OF COMPETENCY IN THE SUBJECT AREA.
- 3 (F) THAT THE PUBLIC SCHOOLS SHALL PROVIDE EACH HIGH SCHOOL
- 4 PUPIL AND HIS OR HER PARENT, GUARDIAN, OR PERSON IN LOCO PARENTIS
- 5 WITH ASSISTANCE IN DEVELOPING AND MAINTAINING AN INDIVIDUALIZED
- 6 EDUCATION/EMPLOYABILITY PLAN THAT CLEARLY OUTLINES THE NECESSARY
- 7 STEPS FOR SUCCESSFULLY COMPLETING THE AREA OR AREAS OF STUDY
- 8 SELECTED BY THE PUPIL AND HIS OR HER PARENT, GUARDIAN, OR PERSON
- 9 IN LOCO PARENTIS.
- 10 (G) THAT, IF AN EMPLOYER IN THIS STATE EMPLOYS AN INDIVIDUAL
- 11 WHO HAS RECEIVED A HIGH SCHOOL DIPLOMA FROM A SCHOOL DISTRICT AND
- 12 DETERMINES THROUGH AN APPROPRIATE ASSESSMENT WITHIN 2 YEARS AFTER
- 13 THE INDIVIDUAL RECEIVED THE DIPLOMA THAT THE INDIVIDUAL IS DEFI-
- 14 CIENT IN 1 OR MORE BASIC SKILL AREAS THAT ARE IDENTIFIED BY THE
- 15 CABINET AS NECESSARY FOR BASIC EMPLOYMENT, THE EMPLOYER AND THE
- 16 INDIVIDUAL MAY APPLY TO THE SCHOOL DISTRICT FOR AND RECEIVE FROM
- 17 THE SCHOOL DISTRICT AN EDUCATIONAL WARRANTY CERTIFICATE ENTITLING
- 18 THE INDIVIDUAL TO RECEIVE REMEDIAL INSTRUCTION IN EACH BASIC
- 19 SKILL AREA IN WHICH THE INDIVIDUAL WAS FOUND BY THE ASSESSMENT TO

- 21 (H) THAT TEACHERS IN THE PUBLIC SCHOOLS SHALL COMPLETE AT
- 22 LEAST 20 DAYS OF CONTINUING EDUCATION IN THEIR SUBJECT AREA EACH
- 23 YEAR.
- 24 (11) AS USED IN THIS SECTION, "LEGISLATIVE COUNCIL" MEANS
- 25 THE LEGISLATIVE COUNCIL CREATED IN THE LEGISLATIVE COUNCIL ACT,
- 26 ACT NO. 268 OF THE PUBLIC ACTS OF 1986, BEING SECTIONS 4.1101 TO
- 27 4.1901 OF THE MICHIGAN COMPILED LAWS.
