

HOUSE BILL No. 4544

EXECUTIVE BUDGET BILL

March 24, 1993, Introduced by Reps. Allen, Dolan, Bender, McBryde, Gilmer, Sikkema, Johnson, Middleton, Oxender and Bobier and referred to the Committee on Appropriations.

A bill to make appropriations for the department of mental health and certain state purposes related to mental hygiene for fiscal years ending September 30, 1994 and September 30, 1995; to provide for the expenditure of such appropriations; to create funds; to provide for reports; to prescribe the powers and duties of certain state agencies and departments; and to provide for disposition of fees and other income received by the various state agencies.

- 1 Sec. 1202. The appropriations made and the expenditures
- 2 authorized under this act and the departments, agencies, commissions,
- 3 boards, offices, and programs for which an appropriation is made under
- 4 this act are subject to the management and budget act, Act No. 431 of
- 5 the Public Acts of 1984, being sections 18.1101 to 18.1594 of the
- 6 Michigan Compiled Laws.
- 7 Sec. 1203. The amounts appropriated for utilities and that
- 8 portion of contractual services, supplies, and materials used to pay
- 9 for utility service to state facilities in section 102 may be expended
- 10 in a manner consistent with the provisions of section 253 of the
- 11 management and budget act, Act No. 431 of the Public Acts of 1984,
- 12 being section 18.1253 of the Michigan Compiled Laws.
- 13 Sec. 1204. As used in this act:
- 14 (a) "ADAMHA" means the United States department of health and
- 15 human services, alcohol, drug abuse, and mental health administration.
- 16 (b) "ADP" means automated data processing.
- 17 (c) "CMH" means community mental health.
- 18 (d) "DAG-FNS" means the United States department of agriculture,
- 19 food and nutrition services.
- 20 (e) "DED-OESE" means the United States department of education,
- 21 office of elementary and secondary education.
- 22 (f) "DED-OESE (ECIA)" means the education consolidation and
- 23 improvement act.

- 14 Sec. 1205. (1) Beginning October 1, 1994, there shall be a hiring 15 freeze imposed on the state classified civil service. State 16 departments and agencies shall be prohibited from hiring any new full-17 time state classified civil service employees or prohibited from 18 filling any vacant state classified civil service positions. This 19 hiring freeze does not apply to internal transfers of classified 20 employees from one position to another within a department or to 21 positions that are funded with 80% or more federal or restricted 22 funds.
- 23 (2) The director of the department of management and budget shall 24 grant exceptions to this hiring freeze when the director believes that 25 such a hiring freeze will result in rendering a state department or 26 agency unable to deliver basic services. The director of the 27 department of management and budget shall report by the fifteenth of 28 each month to the chairpersons of the senate and house appropriations

1 committees the number of exclusions to the hiring freeze approved 2 during the previous month and the reasons to justify the exclusion.

- 3 Sec. 1206. Increases in employee wage compensation which accrue 4 as a result of savings in group insurance costs in accordance with 5 terms of valid collective bargaining agreements shall be paid from 6 appropriation lines in section 102 in which authorization for salary 7 and wage payments are included. If a transfer of appropriations is 8 necessary to adjust for these increased wage levels, the director of 9 the department of management and budget may authorize administrative 10 transfers for this purpose consistent with Section 393(1) of Act 431 11 of the Public Acts of 1984, as amended, being section 18.1393(1) of 12 the Michigan Compiled Laws.
- 13 Sec. 1207. All savings accruing from reduced contribution rates 14 for the state employees retirement system shall be unallotted from 15 appropriation line items as necessary. Such reductions in 16 contribution rates are contingent upon enactment of amendments to the 17 state employees retirement act of 1943, Act No. 240 of the Public Acts 18 of 1943, being sections 38.1 to 38.48 of the Michigan Compiled Laws, 19 including a defined compribution retirement plan for new state 20 employees within the membership of such plan; changes in funding for 21 the provision of dental and vision benefits; five year reconciliation 22 smoothing; use of a 50 year amortization schedule for unfunded 23 actuarial accrued liabilities; and other amendments to the act. The 24 director of the department of management and budget shall issue 25 instructions to all state agencies regarding contribution changes as 26 they occur.

28 Sec. 1301. Funds appropriated in section 102 from the central

- 1 fund for acquiring additional federal grant funds and from the central 2 fund for acquiring private funds shall not be expended until the grant 3 money is actually authorized by the grantor. Funds accepted under 4 this section shall not be authorized if the receipt of the funds 5 mandates a commitment for state funding at a future date.
- Sec. 1302. The department shall continue a revenue recapture project to generate additional revenues from third parties related to acases which have been closed or are inactive. Revenues collected through project efforts are appropriated to the department for departmental costs and contractual fees associated with these retroactive collections and to improve ongoing departmental reimbursement management functions so that the need for retroactive collections will be reduced or eliminated.
- Sec. 1303. The department's ability to satisfy appropriation 15 deductions in section 102 shall not be limited to collections and 16 accruals pertaining to services provided in fiscal year 1994-95, but 17 shall also include reimbursements, refunds, adjustments, and 18 settlements from prior years.
- 19 Sec. 1304. Funds appropriated in section 102 for the mental 20 health advisory council may be used for member per diems of \$50.00 and 21 other council expenditures with approval of the council and the 22 director of the department of mental health. Funds may also be used 23 for the expenses of the state mental health advisory council on 24 deafness and other expenses for councils established by the mental 25 health code.
- Sec. 1305. Unexpended and unencumbered amounts and accompanying 27 expenditure authorizations remaining on September 30, 1995 from the 28 amounts appropriated in section 102 for federal block grants, federal

- 2 for one fiscal year under requests that are consistent with the

- 13 Sec. 1307. The specific amounts indicated in section 102 of this
- 14 act as restricted revenue for financing appropriations from first and
- 15 third parties, HCFA title XIX, CMH-purchase of state service contracts
- 16 and county revenues are estimates of the proportion of the total
- 17 amounts expected to be collected, and the department may satisfy any
- 18 individual restricted revenue deduct amount from the total revenues of
- 19 all of those revenue sources.
- 20 Sec. 1308. The funds appropriated in section 102 for prisoner
- 21 mental health services are for the assumption of responsibilities for
- 22 prisoner mental health in accordance with the interdepartmental plan
- 23 developed in cooperation with the department of corrections. The
- 24 department is authorized to receive and expend funds from the
- 25 department of corrections in addition to the appropriations in section
- 26 102 to fulfill the obligations outlined in the interdepartmental
- 27 agreement.
- 28 COMMUNITY MENTAL HEALTH

- Sec. 1401. (1) Funds allocated in section 102 for community mental health operations include the continuation of transportation services, funded 100% with state funds and include title XX transition 4 grants.
- 5 (2) In addition to the funds appropriated in section 102 for 6 community mental health operations there is appropriated all funds 7 received by CMH boards in additional federal funds. It is intended 8 that the community mental health boards maximize federal funding 9 sources. CMH boards shall retain, contingent upon actual earnings, 10 the amount of increased federal funds above the amounts authorized in 11 the billable services fiscal year ending September 30, 1994 contracts. 12 State funding provided in each CMH board's contract shall not be 13 increased as a result of implementation of this section. 14 Sec. 1402. (1) The funds appropriated in section 102 for purchase
- Sec. 1402. (1) The funds appropriated in section 102 for purchase 15 of state service contracts are for the purchase of state hospital and 16 center services, state administered community residential services, or 17 for approved community-based programs which reduce utilization of 18 state provided services below this appropriated level. These funds 19 shall be allocated to community mental health boards based on 20 estimates approved by the department as part of the negotiated 21 contract.
- 22 (2) Funds which are allocated to community mental health boards, 23 when used to purchase state services, shall be provided to state 24 hospitals, centers, and placement agencies based on the per diem and 25 billing arrangements approved by the department in the negotiated 26 contract.
- 27 Sec. 1403. The funds appropriated in this act for community 28 mental health programs shall not be used to replace funds no longer

- 1 available because the local government or community mental health
- 2 board reduced its base of support for state and local mental health
- 3 services, as defined in chapter 2 of the mental health code, Act No.
- 4 258 of the Public Acts of 1974, being sections 330.1200 to 330.1246 of
- 5 the Michigan Compiled Laws, below that of the previous year.
- 6 Sec. 1404. The funds appropriated in section 102 for community
- 7 mental health programs shall be allocated to community mental health
- 8 boards under a formal contract with the department. The spending
- 9 plans, authorizations, and allocations for each community mental
- 10 health board shall be determined by the department central office
- 11 staff, in cooperation with community mental health boards.
- 12 Sec. 1405. (1) Funds appropriated in section 102 for community
- 13 mental health services may be reserved and carried forward into the
- 14 subsequent fiscal year by a county community mental health board as
- 15 part of the board's financial management plan under requests that are
- 16 consistent with the following provisions of section 451 of P.A. 431 of
- 17 1984, being section 18.1451(3) of the Michigan Compiled Laws:
- 18 (a) the purpose of the project to be carried forward.
- 19 (b) the methods that will be used to accomplish the project.
- 20 (c) the total estimated cost of the project.
- 21 (d) a tentative completion date of the project.
- 22 (2) Funding carried forward shall be limited to the differences
- 23 between the projected cost of community mental health services in the
- 24 subsequent fiscal year and the level of funding available, not to
- 25 exceed 5% of the total community based authorization. A statement of
- 26 intent to carryforward funds shall be submitted and approved by the
- 27 department by the end of the third quarter. This statement shall
- 28 identify the proposed uses of funds to be carried forward.

- 1 (3) Conditions under which funding may be reserved include all of 2 the following:
- (a) Provisions of the contract between the department and county 4 community mental health boards regarding protection of categorical 5 funding shall not be altered.
- 6 (b) Funds may be carried forward only when the performance 7 commitments in the contract for the year from which funding will be 8 reserved are met.
- 9 (c) An expenditure made from a reserve account does not change a 10 board's base allocation or create a full year cost obligation for the 11 department.
- (d) Funding carried forward and not used shall lapse to the state 13 general fund.
- 14 Sec. 1406. The amount appropriated in section 102 for community 15 mental health services is intended for funding of community mental 16 health service boards in accordance with contracts between the 17 department and the boards for the current fiscal year. The department 18 shall establish such total payable and receivable amounts as may be 19 appropriate to represent the expected final state obligation for all 20 such contracts. After final review of the expenditure reports 21 required by the contracts, any amounts advanced to the board which are 22 returned to the department and any amounts paid to the boards in 23 accordance with the provisions of the contracts shall be considered to 24 be adjustments to the program expenditures for prior fiscal years. 25 These prior year transactions shall be recorded in a separate account 26 established for that purpose. Community mental health programs prior 27 year revenue recognized in the current fiscal year may be restricted 28 to finance related prior year expenditures not previously recorded.

- Sec. 1407. The department may advance to a community mental 2 health board an amount not to exceed 1/4 of their estimated total 3 collections from medicaid and may establish a separate accounts
- Sec. 1408. The department is authorized to transfer funds from 6 other accounts in section 102 into the communities first pilot 7 projects line item in order to support such projects. Such transfers 8 shall be subject to the provisions of Act. No. 431 of Public Acts of 9 1984, being section 18.1393 of the Michigan Compiled Laws.

Sec. 1501. The funds appropriated in section 102 for community 12 residential services programs may be used for basic care in cases 13 where individuals are not eligible to receive social security benefits 14 and are not otherwise capable of supporting themselves out of their 15 own resources. Funds may be used for aftercare services or to prevent 16 admissions to state hospitals and centers through residential and 17 support services. Expenditures and allocations may be authorized for 18 community mental health boards and state hospitals, centers, and 19 placement agencies.

20 INSTITUTIONAL SERVICES, HOSPITALS AND CENTERS

Sec. 1601. The department may charge rent to state or other 22 tenants occupying space in any of its facilities. The rental rates 23 and all leasing arrangements shall be subject to the approval of the 24 department of management and budget and the state administrative 25 board. Revenues received under this section shall be available for 26 expenditure by the department for maintenance, renovation, 27 administrative expense associated with the leased space and for other 28 departmental expenditures. Unexpended and unencumbered amounts

- Sec. 1602. The operation and maintenance of the power plant at 11 the Kalamazoo state hospital shall be financed from charges to the 12 appropriations to the Kalamazoo state hospital and Western Michigan 13 University, which charges shall be based upon the cost of the power 14 plant and upon the usage of heat and electrical power by the hospital 15 and the university.
- Sec. 1603. In addition to the amounts appropriated in section 17102, revenues from the sale of sheltered workshop services and 18 products are appropriated to be expended for supplies, equipment, and 19 other costs associated with the maintenance of the sheltered workshop 20 program, excluding costs of compensating state classified employees. 21 The unspent balance on the last day of the fiscal year ending 22 September 30, 1994 shall be carried forward into the subsequent fiscal 3 year.
- Sec. 1604. In addition to the funds appropriated in section 102 25 for state psychiatric hospitals and centers, and following approval by 26 the department of management and budget, the department is authorized 27 to expend restricted funds earned above revenue appropriated for CMH-28 purchase of state service contracts, first/third party revenues or
