

## **HOUSE BILL No. 4628**

April 21, 1993, Introduced by Reps. Scott, Harrison, Pitoniak, Jondahl, Emerson, Gagliardi, Jacobetti, Bennane, Berman, Allen, Sikkema, Dolan, Bobier and Middleton and referred to the Committee on Appropriations.

A bill to create the office of the environmental ombudsman; and to prescribe the powers and duties of the office and certain state agencies and officials.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "environmental ombudsman act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Council" means the legislative council established
- 5 under section 15 of article IV of the state constitution of
- 6 1963.
- 7 (b) "Ombudsman" means the environmental ombudsman created in
- 8 section 3.
- 9 Sec. 3. (1) The office of the environmental ombudsman is
- 10 created in the council.

- 1 (2) The principal executive officer of the office of the 2 environmental ombudsman is the environmental ombudsman.
- 3 (3) The ombudsman shall be appointed by the council for 1
- 4 nonrenewable 6-year term. If the ombudsman fails to serve for
- 5 the entire 6-year period, a successor shall be selected for a
- 6 nonrenewable 6-year term. The ombudsman may be removed by the
- 7 council before the expiration of his or her term for cause.
- 8 Sec. 4. The ombudsman shall perform all of the following
- 9 duties and responsibilities:
- 10 (a) Act within state government on behalf of individuals who
- 11 have concerns regarding the state's system of environmental pro-
- 12 tection and natural resource management, and assist individuals
- 13 in directing and communicating their concerns to the appropriate
- 14 state agency.
- 15 (b) Assist the public in gaining access to the environmental
- 16 protection and natural resource management decision-making pro-
- 17 cess before any final decision is rendered by a state agency.
- (c) Assist the public in obtaining efficient, thorough, and
- 19 timely responses regarding environmental protection and natural
- 20 resource management questions.
- 21 (d) Recommend to appropriate state agencies and the legisla-
- 22 ture methods by which public participation in environmental pro-
- 23 tection and natural resource management decision-making could be
- 24 improved.
- (e) Compile, maintain, and make available upon request a
- 26 complete list of all citizen advisory committees within state

- 1 agencies that are involved with environmental protection and
- 2 natural resource management issues.
- 3 (f) Serve as a liaison between the public and the state
- 4 agencies involved with environmental protection and natural
- 5 resource management issues.
- 6 Sec. 5. All agencies of state government shall cooperate
- 7 fully with the ombudsman, and shall assist the ombudsman in the
- 8 performance of his or her duties and responsibilities under this
- 9 act.
- 10 Sec. 6. The council shall establish procedures for approv-
- 11 ing the budget of the office, for expending funds, and for the
- 12 employment of any personnel of the ombudsman.
- 13 Sec. 7. The responsibilities granted to the ombudsman under
- 14 this act shall not limit or affect any existing rights of public
- 15 participation or appeals related to any programs in any state
- 16 agency, and are intended to be in addition to any such existing
- 17 processes.
- 18 Sec. 8. This act shall take effect April 15, 1994.
- 19 Sec. 9. This act shall not take effect unless all of the
- 20 following bills of the 87th Legislature are enacted into law:
