



HOUSE BILL No. 4735

May 6, 1993, Introduced by Reps. Brown, Munsell, Dalman, Rivers, Dolan, Berman, Schroer, Wallace, Dobb, Kilpatrick, Byrum, Jondahl, Willard, Bankes, Gire, Barns, Bodem, Emerson, Scott, Bobier and Crissman and referred to the Committee on Education.

A bill to amend Act No. 451 of the Public Acts of 1976,
entitled as amended

"The school code of 1976,"

as amended, being sections 380.1 to 380.1852 of the Michigan
Compiled Laws, by adding sections 1277a and 1280a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Act No. 451 of the Public Acts of 1976, as
2 amended, being sections 380.1 to 380.1852 of the Michigan
3 Compiled Laws, is amended by adding sections 1277a and 1280a to
4 read as follows:

5 SEC. 1277A. (1) BEGINNING IN THE 1993-1994 SCHOOL YEAR, THE
6 BOARD OF A SCHOOL DISTRICT SHALL ENSURE ALL OF THE FOLLOWING:

7 (A) THAT ALL INFORMATION ASSEMBLED REGARDING EACH SCHOOL
8 BUILDING WITHIN THE SCHOOL DISTRICT TO PREPARE THE SCHOOL'S
9 ANNUAL EDUCATIONAL REPORT, AS DESCRIBED IN SECTION 1204A, IS

1 DISAGGREGATED BY GENDER AND RACE AND IS PROVIDED TO THE
2 INDIVIDUALS PARTICIPATING IN THE DEVELOPMENT OF THE DISTRICT'S
3 SCHOOL IMPROVEMENT PLAN UNDER SECTION 1277.

4 (B) THAT ALL GENDER OR RACE EQUITY ISSUES RAISED BY THE DIS-
5 AGGREGATED INFORMATION DESCRIBED IN SUBDIVISION (A) ARE ADDRESSED
6 AS PART OF THE PLANNING, DEVELOPMENT, IMPLEMENTATION, EVALUATION,
7 AND UPDATING OF THE SCHOOL IMPROVEMENT PLAN OF EACH SCHOOL WITHIN
8 THE SCHOOL DISTRICT UNDER SECTION 1277 OR, IF SUCH AN ISSUE IS
9 NOT ADDRESSED, THAT AN EXPLANATION IS MADE TO THE COMMUNITY OF
10 THE REASON OR REASONS WHY THE ISSUE IS NOT ADDRESSED. AN EXPLA-
11 NATION FOR NOT ADDRESSING A GENDER OR RACE EQUITY ISSUE MAY BE
12 INCLUDED IN THE SCHOOL'S ANNUAL EDUCATIONAL REPORT UNDER
13 SECTION 1204A.

14 (2) UPON REQUEST BY A SCHOOL DISTRICT, INTERMEDIATE SCHOOL
15 DISTRICT, OR SCHOOL, THE DEPARTMENT SHALL PROVIDE ADVICE AND
16 TECHNICAL ASSISTANCE TO THE DISTRICT OR SCHOOL ON MEETING THE
17 REQUIREMENTS OF THIS SECTION.

18 (3) IN ADDITION TO THE REQUIREMENTS SPECIFIED IN
19 SECTION 1280 FOR ACCREDITATION UNDER THAT SECTION, A SCHOOL SHALL
20 NOT BE ACCREDITED BY THE DEPARTMENT UNDER SECTION 1280 UNLESS THE
21 DEPARTMENT DETERMINES THAT THE SCHOOL AND ITS SCHOOL DISTRICT
22 MEET THE REQUIREMENTS OF THIS SECTION.

23 SEC. 1280A. THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE
24 SCHOOL DISTRICT THAT OPERATES OR PARTICIPATES IN A CONSORTIUM
25 THAT OPERATES AN ALTERNATIVE EDUCATIONAL PROGRAM PURSUANT TO
26 SECTION 1301, A VOCATIONAL-TECHNICAL SKILLS CENTER OR OTHER
27 SEPARATE VOCATIONAL EDUCATION PROGRAM, OR ANY OTHER TYPE OF

1 SPECIALIZED OR ALTERNATIVE SCHOOL OR PROGRAM SHALL ENSURE THAT
2 THE REQUIREMENTS OF SECTIONS 1204A, 1277, 1277A, 1278, AND 1280
3 ARE MET FOR EACH OF THOSE SCHOOLS OR PROGRAMS.
