## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 368 of the Public Acts of 1978, as
- 2 amended, being sections 333.1101 to 333.25211 of the Michigan
- 3 Compiled Laws, is amended by adding section 21055a to read as
- 4 follows:
- 5 SEC. 21055A. (1) EXCEPT FOR A HOSPITAL OR PROVIDER THAT HAS
- 6 A CONTRACTUAL RELATIONSHIP WITH A HEALTH MAINTENANCE ORGANI-
- 7 ZATION, A HEALTH MAINTENANCE ORGANIZATION THAT GENERATES A PAPER
- 8 BILLING SHALL REQUIRE THE USE OF A STANDARD MEDICAL CLAIM FORM
- 9 THAT MAY BE PROVIDER SPECIFIC ESTABLISHED BY THE COMMISSIONER
