

HOUSE BILL No. 4780

May 12, 1993, Introduced by Rep. Joe Young, Jr. and referred to the Committee on State Affairs.

A bill to amend section 4 of Act No. 95 of the Public Acts of 1981, entitled

"The precious metal and gem dealer act,"

as amended by Act No. 34 of the Public Acts of 1990, being section 445.484 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 4 of Act No. 95 of the Public Acts of
- 2 1981, as amended by Act No. 34 of the Public Acts of 1990, being
- 3 section 445.484 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 4. (1) A dealer shall maintain a permanent record of
- 6 each transaction, on record of transaction forms provided for in
- 7 subsection (6), legibly written in ink in the English language.
- 8 Each record of transaction form shall be filled out in
- 9 quadruplicate by the dealer or agent or employee of the dealer.

- 1 One copy of the form shall go to the appropriate police agency or
- 2 sheriff's department pursuant to subsection (3); 1 copy shall go
- 3 to the customer; and 1 copy shall be retained by the dealer pur-
- 4 suant to subsection (5). At the time a dealer receives or pur-
- 5 chases a precious item, the dealer or the agent or employee of
- 6 the dealer shall insure that the following information is
- 7 recorded accurately on a record of transaction form:
- 8 (a) The dealer certificate of registration number.
- 9 (b) A general description of the precious item or precious
- 10 items received or purchased, including the type of metal or pre-
- II cious gem. In the case of watches, the description shall contain
- 12 the name of the maker and the number of both the works and the
- 13 case. In the case of jewelry, all letters and marks inscribed on
- 14 the jewelry shall be included in the description.
- 15 (c) The date of the transaction.
- (d) The name of the person conducting the transaction.
- (e) The name, date of birth, driver's license number or
- 18 state of Michigan personal identification card number, and street
- 19 and house number of the customer, together with a legible imprint
- 20 of the right thumb of the customer, or if that is not possible,
- 21 of the left thumb or a finger of the customer. However, the
- 22 thumbprint or fingerprint shall only be required on the record of
- 23 transaction form retained by the dealer. The thumbprint or fin-
- 24 gerprint shall be made available to a police agency during the
- 25 course of a police investigation involving a precious item or
- 26 items described on the record of transaction. After a period of
- 27 1 year from the date of the record of transaction, if a police

- 1 investigation concerning a precious item or items described on
- 2 the record of transaction has not occurred, the dealer and any
- 3 police agency or sheriff's department holding a copy of the
- 4 record of transaction shall destroy, and not keep a permanent
- 5 record of, the record of transaction. A dealer who goes out of
- 6 business or changes his or her business address to another local
- 7 jurisdiction either within or out of this state shall transmit
- 8 the records of all transactions made by the dealer within 1 year
- 9 before his or her closing or moving, to the local police agency.
- (f) The price to be paid by the dealer for the precious item
- II or precious items.
- (g) The form of payment made to the customer; check, money
- 13 order, bank draft, or cash. If the payment is by check, money
- 14 order, or bank draft, the dealer shall indicate the number of the
- 15 check, money order, or bank draft.
- (h) The customer's signature.
- 17 (2) The record of each transaction shall be numbered consec-
- 18 utively, commencing with the number 1 and the calendar year.
- 19 (3) Within 48 hours after receiving or purchasing a precious
- 20 item, the dealer shall send a copy of the record of transaction
- 21 form to the local police agency and, if the record of transaction
- 22 form indicates that the customer resides outside the jurisdiction
- 23 of the local police agency, shall send a copy of the record of
- 24 transaction form to the police agency of the city, village, or
- 25 township in which the customer resides as set forth on the record
- 26 of transaction, or, if that city, village, or township does not
- 27 have a police agency, to the sheriff's department of the county

- 1 in which the customer resides as set forth on the record of
- 2 transaction. The record of transaction forms received by a
- 3 police agency or sheriff's department shall not be open to
- 4 inspection by the general public. Each police agency or
- 5 sheriff's department holding record of transaction forms shall be
- 6 responsible for insuring the confidentiality of the record of
- 7 transaction forms and insuring that the record of transaction
- 8 forms are used only for the purpose for which they were
- 9 received.
- 10 (4) The record of transaction forms of a dealer and each
- 11 precious item received shall be open to an inspection by the
- 12 county prosecuting attorney, the local police agency, the police
- 13 agency or sheriff's department of the local governmental unit in
- 14 which the customer resides -, and the Michigan state police, at
- 15 all times during the ordinary business hours of the dealer. As a
- 16 condition of doing business, a dealer is considered to have given
- 17 consent to the inspection prescribed by this subsection. The
- 18 record of transaction forms of a dealer shall not be open to
- 19 inspection by the general public.
- 20 (5) Except as otherwise provided in this section, each
- 21 record of a transaction shall be retained by the dealer for not
- 22 less than 1 year after the transaction to which the record
- 23 pertains.
- (6) The form of the record of transaction shall have an
- 25 8-1/2 by 11 inch size and shall be as follows:
