

HOUSE BILL No. 4789

May 18, 1993, Introduced by Reps. Anthony, DeMars, Wallace, Llewellyn, Varga, Dobronski, Agee, Baade, Rivers, Cropsey, Byrum, Wetters, Curtis, Harder, Barns, Shepich, Griffin, Bobier, Dolan, Gernaat, Jersevic, Lowe, McBryde, McManus, Middleton, Middaugh, Allen, Dobb, Gire, Berman, Keith, Schroer, Rocca, Points, Pitoniak and Freeman and referred to the Committee on Conservation, Environment and Great Lakes.

A bill to amend Act No. 106 of the Public Acts of 1963,

entitled

"An act to define, control and prohibit the littering of public and private property and waters; to prescribe penalties for violation of this act; and to repeal certain acts and parts of acts,"

as amended, being sections 752.901 to 752.906 of the Michigan Compiled Laws, by adding sections 3b and 3c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 106 of the Public Acts of 1963, as
- 2 amended, being sections 752.901 to 752.906 of the Michigan
- 3 Compiled Laws, is amended by adding sections 3b and 3c to read as
- 4 follows:
- 5 SEC. 3B. A PERSON WHO VIOLATES A CRIMINAL PROVISION IN THIS
- 6 ACT IS SUBJECT TO THE FORFEITURE OF PROPERTY PROVISIONS OF
- 7 CHAPTER 47 OF THE REVISED JUDICATURE ACT OF 1961, ACT NO. 236 OF

- 3 SEC. 3C. (1) A PERSON WHO VIOLATES THIS ACT WHERE THE

- 15 BE REMEDIED BY ANY MEANS AUTHORIZED UNDER ACT NO. 236 OF THE
- 16 PUBLIC ACTS OF 1961, BEING SECTIONS 600.101 TO 600.9947 OF THE
