

HOUSE BILL No. 4797

May 18, 1993, Introduced by Reps. Dalman, Bobier, Dobb, Nye, London, Johnson, McNutt, Bender, Jamian, Richard A. Young, Gilmer, Griffin, Bodem, Rhead, Horton, Harder, Hammerstrom and Hill and referred to the Committee on Public Retirement.

A bill to amend section 42 of Act No. 182 of the Public Acts of 1986, entitled

"State police retirement act of 1986,"

as amended by Act No. 191 of the Public Acts of 1989, being section 38.1642 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 42 of Act No. 182 of the Public Acts of
- 2 1986, as amended by Act No. 191 of the Public Acts of 1989, being
- 3 section 38.1642 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 42. (1) Hospitalization and medical coverage insurance
- 6 premiums payable by a retirant or his or her retirement allowance
- 7 beneficiary and his or her dependents under any group health plan
- 8 authorized by the Michigan civil service commission and the
- 9 department shall be paid in amounts provided by this subsection

- from appropriations for this purpose made to the retirement
- 2 system. Until October 1, 1989, the amount payable by the retire-
- 3 ment system shall be 90% of the entire monthly premium payable
- 4 for hospitalization and medical coverage insurance. Beginning
- 5 October 1, 1989, the amount payable by the retirement system
- 6 shall be 95% of the entire monthly premium payable for hospital-
- 7 ization and medical coverage insurance.
- 8 (2) Effective October 1, 1989, dental coverage and vision
- 9 coverage insurance premiums payable by a retirant or his or her
- 10 retirement allowance beneficiary and his or her dependents under
- 11 any group health plan authorized by the Michigan civil service
- 12 commission and the department shall be paid in amounts provided
- 13 by this subsection from appropriations for this purpose made to
- 14 the retirement system. The amount payable by the retirement
- 15 system shall be 90% of the entire monthly premium payable for
- 16 dental coverage and vision coverage insurance.
- 17 (3) The health-dental-vision benefits fund is created and
- 18 shall be the fund into which appropriations of the state for
- 19 health, dental, and vision benefits are paid. Benefits payable
- 20 pursuant to subsections (1) and (2) shall be payable from the
- 21 health-dental-vision benefits fund.
- 22 (4) IF A PERSON HAS NOT MET THE SERVICE REQUIREMENTS TO
- 23 RECEIVE A RETIREMENT ALLOWANCE UNDER THIS ACT ON DECEMBER 31,
- 24 1993, AND PRESCRIPTION INSURANCE IS PROVIDED TO THAT PERSON UPON
- 25 RETIREMENT, THAT PERSON SHALL PAY A CO-PAY IN AN AMOUNT DETER-
- 26 MINED BY THE MICHIGAN CIVIL SERVICE COMMISSION FOR EACH COVERED
- 27 PRESCRIPTION.
