

HOUSE BILL No. 4819

May 27, 1993, Introduced by Reps. Profit, Rivers, Gire, Bennane and Byrum and referred to the Committee on Public Health.

A bill to amend section 6213 of Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

being section 333.6213 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 6213 of Act No. 368 of the Public Acts
- 2 of 1978, being section 333.6213 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 6213. (1) The administrator, with the advice and con-
- 5 sent of a majority of the members of the commission appointed and
- 6 serving, shall:
- 7 (a) Annually establish program priority for funding for the
- 8 next fiscal year, AND FOR EACH PROGRAM OFFERING SUBSTANCE ABUSE
- 9 TREATMENT AND REHABILITATION SERVICES, GIVE PRIORITY TO BOTH OF

- (i) A PROGRAM THAT ENSURES THAT SUBSTANCE ABUSE TREATMENT
- 2 AND REHABILITATION SERVICES PROVIDED BY THE PROGRAM TO A CUSTO-
- 3 DIAL PARENT OF A CHILD LESS THAN 18 YEARS OF AGE INCLUDES EVALU-
- 4 ATION OF AND, IF APPROPRIATE, TREATMENT FOR THAT CHILD.
- 5 (ii) A PROGRAM THAT ENSURES THAT SUBSTANCE ABUSE TREATMENT
- 6 AND REHABILITATION SERVICES PROVIDED BY THE PROGRAM TO A PERSON
- 7 LESS THAN 18 YEARS OF AGE ARE MADE AVAILABLE TO THE CUSTODIAL
- 8 PARENT OR PARENTS OF THAT PERSON.
- 9 (b) Establish guidelines for project applications.
- 10 (c) Insure ENSURE that applicants for state administered
- II public funds are licensed, unless exempt, as substance abuse
- 12 service organizations under this part.
- (d) Promulgate rules concerning matching requirements for
- 14 state alcoholism and drug abuse treatment grants. The rules
- 15 shall be reviewed every 2 years.
- (2) With the assistance of the department, the administrator
- 17 may issue licenses; require reports; establish standards and pro-
- 18 cedures; and make inspections necessary to enforce this article
- 19 and rules promulgated under this article; and provide technical
- 20 assistance for the guidance of substance abuse service organi-
- 21 zations in complying with the requirements of this article and
- 22 rules promulgated under this article.
