June 15, 1993, Introduced by Reps. Gnodtke, Alley, Middaugh, Anthony, Shepich, Wetters, Rhead, Randall, Gilmer, Bobier, Gernaat, McManus, Brackenridge, Shugars, DeMars and Gustafson and referred to the Committee on Agriculture and Forestry.

A bill to amend section 7 of Act No. 641 of the Public Acts of 1978, entitled as amended

"Solid waste management act,"

as amended by Act No. 28 of the Public Acts of 1992, being section 299.407 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 7 of Act No. 641 of the Public Acts of
- 2 1978, as amended by Act No. 28 of the Public Acts of 1992, being
- 3 section 299.407 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 7. (1) "Solid waste" means garbage, rubbish, ashes,
- 6 incinerator ash, incinerator residue, street cleanings, municipal
- 7 and industrial sludges, solid commercial and solid industrial
- 8 waste, and animal waste other than organic waste generated in the

- 1 production of livestock and poultry. Solid waste does not
- 2 include the following:
- 3 (a) Human body waste.
- 4 (b) Medical waste as it is defined in part 138 of the public
- 5 health code, Act No. 368 of the Public Acts of 1978, being sec-
- 6 tions 333.13801 to 333.13831 of the Michigan Compiled Laws, and
- 7 regulated under part 138 of Act No. 368 of the Public Acts of
- 8 1978 and section 5a of the air pollution act, Act No. 348 of the
- 9 Public Acts of 1965, being section 336.15a of the Michigan
- 10 Compiled Laws.
- (c) Organic waste generated in the production of livestock
- 12 and poultry.
- (d) Liquid waste.
- (e) Ferrous or nonferrous scrap directed to a scrap metal
- 15 processor or to a reuser of ferrous or nonferrous products.
- (f) Slag or slag products directed to a slag processor or to
- 17 a reuser of slag or slag products.
- (g) Sludges and ashes managed as recycled, or nondetrimental
- 19 materials appropriate for agricultural or silvicultural use pur-
- 20 suant to a plan approved by the director. AGRICULTURAL USES THAT
- 21 INVOLVE THE LAND APPLICATION OF BY-PRODUCTS FROM FRUIT AND VEGE-
- 22 TABLE PROCESSING DO NOT REQUIRE A PLAN DESCRIBED IN THIS
- 23 SUBDIVISION.
- (h) Materials approved for emergency disposal by the
- 25 director.
- 26 (i) Source separated materials.

- 1 (j) Site separated material.
- 2 (k) Fly ash or any other ash produced from the combustion of
- 3 coal, when used in the following instances:
- 4 (i) With a maximum of 6% of unburned carbon as a component
- 5 of concrete, grout, mortar, or casting molds.
- 6 (ii) With a maximum of 12% unburned carbon passing
- 7 M.D.O.T. test method MTM 101 when used as a raw material in
- 8 asphalt for road construction.
- 9 (iii) As aggregate, road, or building material which in
- 10 ultimate use will be stabilized or bonded by cement, limes, or
- 11 asphalt.
- 12 (iv) As a road base or construction fill which is covered
- 13 with asphalt, concrete, or other material approved by the direc-
- 14 tor and which is placed at least 4 feet above the seasonal
- 15 groundwater table.
- 16 (v) As the sole material in a depository designed to
- 17 reclaim, develop, or otherwise enhance land, subject to the
- 18 approval of the director. In evaluating the site, the director
- 19 shall consider the physical and chemical properties of the ash
- 20 including leachability, and the engineering of the depository,
- 21 including, but not limited to, the compaction, control of surface
- 22 water and groundwater that may threaten to infiltrate the site,
- 23 and evidence that the depository is designed to prevent water
- 24 percolation through the material.
- 25 (1) Other wastes regulated by statute.
- 26 (2) "Solid waste hauler" means a person who owns or operates
- 27 a solid waste transporting unit.

- 1 (3) "Solid waste processing plant" means a tract of land,
 2 building, unit, or appurtenance of a building or unit or a combi3 nation of land, buildings, and units that is used or intended for
 4 use for the processing of solid waste or the separation of mate5 rial for salvage or disposal, or both, but does not include a
 6 plant engaged primarily in the acquisition, processing, and ship7 ment of ferrous or nonferrous metal scrap, or a plant engaged
 8 primarily in the acquisition, processing, and shipment of slag or
 9 slag products.
- (4) "Solid waste transporting unit" means a container which may be an integral part of a truck or other piece of equipment used for the transportation of solid waste.
- (5) "Solid waste transfer facility" means a tract of land, a 14 building and any appurtenances, or a container, or any combina15 tion of land, buildings, or containers that is used or intended 16 for use in the rehandling or storage of solid waste incidental to 17 the transportation of the solid waste, but is not located at the 18 site of generation or the site of disposal of the solid waste.
- 19 (6) "Source separated material" means glass, metal, wood,
 20 paper products, plastics, rubber, textiles, garbage, yard clip21 pings, or any other material approved by the director that is
 22 separated at the source of generation for the purpose of conver23 sion into raw materials or new products.
- (7) "Yard clippings" means leaves, grass clippings, vegeta25 ble or other garden debris, shrubbery, or brush or tree trimmings
 26 less than 4 feet in length and 2 inches in diameter, that can be
 27 converted to compost humus. This term does not include stumps,

1 agricultural wastes, animal waste, roots, sewage sludge, or

2 garbage.
