

HOUSE BILL No. 4884

June 24, 1993, Introduced by Reps. Porreca, Gire, Schroer, Pitoniak, Profit and Owen and referred to the Committee on Transportation.

A bill to amend section 17 of Act No. 204 of the Public Acts of 1967, entitled as amended

"Metropolitan transportation authorities act of 1967," being section 124.417 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 17 of Act No. 204 of the Public Acts of
- 2 1967, being section 124.417 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 17. (1) Except in the purchase of unique articles or
- 5 articles which, for any other reason, cannot be obtained in the
- open market and except as otherwise provided in this section and
- 7 in section 24, competitive bids shall be secured before any pur-
- 8 chase or sale, by contract or otherwise is made or before any
- 9 contract is awarded for construction, alterations, supplies,
- 10 equipment, repairs, or maintenance or for rendering any services

- 1 to the authority other than professional services; and the
- 2 purchase shall be made from or the contract shall be awarded to
- 3 the lowest RESPONSIVE AND responsible bidder; or a sale to the
- 4 highest RESPONSIVE AND responsible bidder. The authority may
- 5 reject any and all such bids or proposals. -No- A purchase of
- 6 any unique article or other articles which cannot be obtained in
- 7 the open market shall NOT be made without express approval of the
- 8 board where the amount involved is in excess of -\$5,000.00
- 9 \$25,000.00.
- 10 (2) All purchases and sales in excess of \$\frac{\\$5,000.00}{\}
- 11 \$25,000.00 shall be awarded after advertising in a local newspa-
- 12 per of general circulation in the metropolitan area at least 2
- 13 weeks prior to BEFORE the bid opening. Bids shall be publicly
- 14 opened and read aloud at a date, time, and place designated in
- 15 the invitation to bid. Invitations to bid shall be sent at least
- 16 1 week -prior to BEFORE the bid opening to at least 3 potential
- 17 bidders who are qualified technically and financially to submit
- 18 bids, or in lieu thereof a memorandum shall be kept on file
- 19 showing that less than 3 potential bidders who are so qualified
- 20 exist in the market area within which it is practicable to obtain
- 21 bids.
- 22 (3) Written EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION,
- 23 WRITTEN price quotations from at least 3 qualified and responsi-
- 24 ble vendors shall be obtained for all purchases and sales -under
- 25 \$5,000.00 and OF \$25,000.00 OR LESS BUT over \$1,000.00
- 26 \$5,000.00, or in lieu thereof, a memorandum shall be kept on
- 27 file showing that less than 3 vendors so qualified exist in the

- 1 market area within which it is practicable to obtain quotations.
- 2 r except as hereinafter provided.
- 3 (4) Purchases or sales under \$1,000:00 \$5,000.00 may be
- 4 negotiated with or without competitive bidding under procurement
- 5 procedures as promulgated and established by the general
- 6 manager.
- 7 (5) Competitive bidding requirements may be waived if it is
- 8 determined by the general manager, or in such other manner as the
- 9 board may provide, by regulation, that an emergency directly and
- 10 immediately affecting service, or public health, safety, or wel-
- 11 fare requires immediate delivery of supplies, materials,
- 12 equipment, or services.
