

HOUSE BILL No. 4896

June 29, 1993, Introduced by Reps. Bodem, Kukuk, Hammerstrom, Porreca, Gernaat, Stille, Middaugh, Alley, Gnodtke, Shepich, Jacobetti and Lowe and referred to the Committee on Agriculture and Forestry.

A bill to amend the title and sections 1, 2, 3, 5, 7, and 8 of Act No. 182 of the Public Acts of 1962, entitled

"An act to prohibit the cutting, removal, transportation or sale within this state, for any purpose, of Christmas trees, evergreen boughs or other trees, shrubs or vines, or certain native plants, without a bill of sale or other proof of ownership from the owner of the land on which the same are grown; to provide for the enforcement of this act; to prescribe penalties for violation thereof; and to repeal certain acts and parts of acts,"

being sections 320.411, 320.412, 320.413, 320.415, 320.417, and 320.418 of the Michigan Compiled Laws; and to repeal certain parts of the act.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. The title and sections 1, 2, 3, 5, 7, and 8 of
- 2 Act No. 182 of the Public Acts of 1962, being sections 320.411,
- 3 320.412, 320.413, 320.415, 320.417, and 320.418 of the Michigan
- 4 Compiled Laws, are amended to read as follows:

- 14 erty owned by the person, unless he has in possession OR SHE

- 18 not owned by the person, unless EITHER OF THE FOLLOWING HAVE BEEN

- 1 Sec. 3. -No- A person shall NOT sell or offer for sale -any
- 2 of the trees, boughs, shrubs, vines or plants listed in section
- 3 +- A PLANT without having in his OR HER possession the evidence
- 4 of title prescribed by section 2, -nor OR without furnishing the
- 5 purchaser a bill of sale or other evidence of title acquisition
- 6 in A form -to-be- prescribed by the department of -agriculture-
- 7 NATURAL RESOURCES OR'THE UNITED STATES FOREST SERVICE. Vendors-
- 8 A VENDOR shall maintain and keep RECORDS OF HIS OR HER
- 9 TRANSACTIONS for -such THE period of time -such records of their
- 10 transactions as THAT the department of agriculture shall
- 11 NATURAL RESOURCES OR THE UNITED STATES FOREST SERVICE PRESCRIBES
- 12 by RULE OR regulation. prescribe.
- 13 Sec. 5. -Any A law enforcement officer -having WHO HAS
- 14 probable cause to believe that -any-section of this act is being
- 15 violated, including authorized employees of the department of
- 16 -conservation and the department of agriculture, shall have the
- 17 power to make NATURAL RESOURCES, MAY CONDUCT inspections to
- 18 determine whether any provisions of this act have HAS been
- 19 violated, which power shall-include INCLUDING the right to stop
- 20 any vehicle THAT IS TRANSPORTING A PLANT at any time; -- to
- 21 inspect and make copies of bills of sale or other -evidences-
- 22 EVIDENCE of title prescribed by the department of agriculture,
- 23 NATURAL RESOURCES OR THE UNITED STATES FOREST SERVICE; to arrest
- 24 persons found to have any of the trees, boughs, shrubs, vines or
- 25 plants prescribed in section 1 in possession A PERSON THAT POS-
- 26 SESSES A PLANT in violation of the terms of this act, and to
- 27 seize and hold any such trees, boughs, shrubs, vines or plants

- 1 PLANT, INCLUDING EQUIPMENT USED TO REMOVE OR TRANSPORT THESE
- 2 ITEMS, subject to the order of the court. A PLANT OR ITEM SEIZED
- 3 PURSUANT TO THIS SECTION SHALL BE DISPOSED OF AS REQUIRED UNDER
- 4 SECTIONS 3 AND 4 OF ACT NO. 192 OF THE PUBLIC ACTS OF 1929, BEING
- 5 SECTIONS 300.13 AND 300.14 OF THE MICHIGAN COMPILED LAWS. Failure
- 6 to exhibit a bill of sale or other evidence of title prescribed

- 10 EXIST.
- 11 Sec. 7. The director of agriculture THE DEPARTMENT OF
- 12 NATURAL RESOURCES, in cooperation with the department of conser-
- 13 vation and law enforcement agencies, shall enforce the provi-
- 14 sions of this act. The director of agriculture THE DEPARTMENT
- 15 OF NATURAL RESOURCES shall -make such- PROMULGATE rules -and
- 16 regulations as he -deems OR SHE CONSIDERS necessary for the
- 17 enforcement of this act in accordance with the provisions of Act
- 18 No. 88 of the Public Acts of 1943, as amended, being sections
- 19 24.71 to 24.82 of the Compiled Laws of 1948, and subject to Act
- 20 No. 197 of the Public Acts of 1952, as amended, being sections
- 21 24.101 to 24.110 of the Compiled Laws of 1948 PURSUANT TO THE
- 22 ADMINISTRATIVE PROCEDURES ACT OF 1969, ACT NO. 306 OF THE PUBLIC

- 25 Sec. 8. (1) Violation of any of the provisions of A
- 26 PERSON WHO VIOLATES this act is GUILTY OF a misdemeanor. The
- 27 forgery of any

- 1 (2) A PERSON WHO FORGES A bill of sale or other evidence of
- 2 title prescribed by the department of agriculture NATURAL
- 3 RESOURCES OR THE UNITED STATES FOREST SERVICE is GUILTY OF a
- 4 misdemeanor.
- 5 (3) A PERSON WHO REMOVES OR CUTS A PLANT IN VIOLATION OF
- 6 THIS ACT IS LIABLE TO THE STATE FOR 3 TIMES THE FAIR MARKET VALUE
- 7 OF THE DAMAGE CAUSED BY THE UNLAWFUL ACT. DAMAGES COLLECTED PUR-
- 8 SUANT TO THIS SUBSECTION SHALL BE CREDITED TO THE GAME AND FISH
- 9 PROTECTION FUND CREATED IN THE HUNTING AND FISHING LICENSE ACT,
- 10 ACT NO. 86 OF THE PUBLIC ACTS OF 1980, BEING SECTIONS 316.101 TO
- 11 316.902 OF THE MICHIGAN COMPILED LAWS.
- 12 Section 2. Section 9 of Act No. 182 of the Public Acts of
- 13 1962, being section 320.419 of the Michigan Compiled Laws, is
- 14 repealed.
