

## **HOUSE BILL No. 5081**

October 7, 1993, Introduced by Rep. Gagliardi and referred to the Committee on State Affairs.

A bill to authorize the state administrative board to convey certain parcels of state owned property in Luce county; to prescribe conditions for the conveyances; and to provide for the disposition of revenue derived from the conveyances.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. The state administrative board, on behalf of the
- 2 state, may convey to the county of Luce, for consideration of
- 3 \$1.00, certain parcels of property comprising the former Newberry
- 4 state home and located in the city of Newberry, Luce county,
- 5 Michigan, which are more particularly described as follows:

- Sec. 2. The conveyances authorized by this act shall be by
- 17 quitclaim deed approved by the attorney general and shall reserve
- 18 to the state all rights to coal, oil, gas, and other minerals
- 19 found on, within, or under the property conveyed.
- Sec. 3. The revenue received under this act shall be depos-
- 21 ited in the state treasury and credited to the general fund.
