## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 3 (4) "Noncontributory service means credited service
- 4 rendered under the noncontributory plan
- 5 (5) "Nonteacher" means a person employed by a reporting unit

- 8 Michigan public schools before July 1, 1945
- 9 (2) "Out of system public education service' means service

- (b) Performed at the university of Michigan, Michigan state

- 14 Sec 7 (1) 'Refund beneficiary means 1 or more persons
- 15 whom the member or former member nominates in writing and files
- 16 with the retirement system for the purpose of being paid accumu-
- 17 lated contributions in the event of the death of the member or
- 18 former member If a valid nomination is not on file, the retire-
- 19 ment board shall pay the accumulated contributions to the legal
- 20 representative of the deceased member or deceased former member,
- 21 if any, or to the estate of the deceased member or deceased
- 22 former member
- 23 (2) 'Regular interest' means interest at 1 or more rates per
- 24 annum determined by the retirement board and compounded
- 25 annually
- (3) 'Reporting unit' means a public school district,
- 27 intermediate school district tax supported community or junior

- 1 college, -college, or university, or an agency having employees
- 2 on its payroll who are members of this retirement system The
- 3 reporting unit shall be the employer for purposes of this act
- 4 BEGINNING ON THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED
- 5 THIS SENTENCE, REPORTING UNIT DOES NOT INCLUDE A UNIVERSITY,
- 6 EXCEPT TO THE EXTENT THAT UNIVERSITY HAS EMPLOYEES ON ITS PAYROLL
- 7 WHO ARE MEMBERS OF THIS RETIREMENT SYSTEM
- 8 (4) "Retirant' means a member who retires with a retirement
- 9 allowance payable from reserves of the retirement system
- (5) "Retirement allowance means a payment for life or a
- 11 temporary period provided for in this act to which a retirant,
- 12 retirement allowance beneficiary or refund beneficiary is
- 13 entitled
- (6) "Retirement allowance beneficiary' means a person who is
- 15 being paid or has entitlement to the payment of a retirement
- 16 allowance in the event of the death of a member, deferred member,
- 17 or retirant
- 18 (7) Retirement board means the board provided to adminis-
- 19 ter this retirement system
- (8) "Retirement system" means the Michigan public school
- 21 employees retirement system provided for in this act
- 22 Section 2 Act No 156 of the Public Acts of 1967, being
- 23 sections 38 381 to 38 388 of the Michigan Compiled Laws, is
- 24 repealed
