- SEC 3C (1) IN ADDITION TO THE UNFAIR, UNCONSCIONABLE OR
- 6 DECEPTIVE METHODS, ACTS, OR PRACTICES IN THE CONDUCT OF TRADE OR
- 7 COMMERCE DEFINED IN SECTION 3, IT IS UNLAWFUL FOR A PERSON WHO
- 8 MANUFACTURES OR DISTRIBUTES IN THIS STATE OR CAUSES TO BE
- 9 MANUFACTURED OR DISTRIBUTED IN THIS STATE A PRODUCT OR DEVICE
