A bill to amend Act No 116 of the Public Acts of 1954, entitled

"Michigan election law,"

as amended, being sections 168 1 to 168 992 of the Michigan Compiled Laws, by adding section 20

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Act No 116 of the Public Acts of 1954, as
- 2 amended, being sections 168 1 to 168 992 of the Michigan Compiled
- 3 Laws, is amended by adding section 20 to read as follows
- 4 SEC 20 (1) AT THE TIME A PERSON WHO IS SEEKING THE NOMI-
- 5 NATION FOR ELECTIVE OFFICE FILES A NOMINATING PETITION OR A
- 6 FILING FEE IN LIEU OF A NOMINATING PETITION UNDER THIS ACT, OR A
- 7 PERSON WHO IS SEEKING TO QUALIFY TO APPEAR ON AN ELECTION BALLOT
- 8 FILES A QUALIFYING PETITION UNDER THIS ACT, THE PERSON SHALL ALSO

- 1 FILE AN AFFIDAVIT AS REQUIRED IN THIS SECTION THE AFFIDAVIT
- 2 SHALL INCLUDE ALL OF THE FOLLOWING INFORMATION
- 3 (A) THE NAME OF THE PERSON SEEKING THE NOMINATION FOR ELEC-
- 4 TIVE OFFICE OR SEEKING TO OUALIFY TO APPEAR ON AN ELECTION
- 5 BALLOT
- 6 (B) THE ELECTIVE OFFICE THAT THE PERSON IS SEEKING
- 7 (C) ONE OR MORE OF THE FOLLOWING STATEMENTS, AS APPLICABLE
- 8 (1) A STATEMENT THAT THE PERSON SEEKING ELECTIVE OFFICE HAS
- 9 NEVER BEEN CONVICTED OF OR PLED NOLO CONTENDERE TO CHILD ABUSE OR
- 10 ANY FELONY IN THIS STATE, ANOTHER STATE, OR THE UNITED STATES
- 11 (11) A STATEMENT THAT THE PERSON SEEKING ELECTIVE OFFICE HAS
- 12 BEEN CONVICTED OF OR PLED NOLO CONTENDERE TO CHILD ABUSE IN THIS
- 13 STATE, ANOTHER STATE, OR THE UNITED STATES
- 14 (111) A STATEMENT THAT THE PERSON SEEKING ELECTIVE OFFICE
- 15 HAS BEEN CONVICTED OF OR PLED NOLO CONTENDERE TO A FELONY IN THIS
- 16 STATE, ANOTHER STATE, OR THE UNITED STATES
- 17 (D) IF THE AFFIDAVIT CONTAINS EITHER STATEMENT UNDER SUBDI-
- 18 VISION (C)(11) OR (111), OR BOTH, A STATEMENT INCLUDING ALL OF
- 19 THE FOLLOWING
- 20 (1) A DESCRIPTION OF EACH CHARGE UPON WHICH THE PERSON WAS
- 21 CONVICTED OR TO WHICH THE PERSON PLED NOLO CONTENDERE
- 22 (11) THE DATE OF EACH CONVICTION OR PLEA
- 23 (111) THE JURISDICTION IN WHICH EACH CONVICTION OR PLEA
- 24 OCCURRED
- 25 (10) THE SENTENCE IMPOSED FOR EACH CONVICTION OR PLEA
- 26 (ν) ANY OTHER INFORMATION THE PERSON SEEKING ELECTIVE OFFICE
- 27 CONSIDERS APPROPRIATE

- 1 (2) THE SECRETARY OF STATE SHALL NOT PRINT OR CAUSE TO BE
- 2 PRINTED UPON AN OFFICIAL BALLOT THE NAME OF A PERSON SEEKING THE
- 3 NOMINATION FOR ELECTIVE OFFICE OR SEEKING TO QUALIFY TO APPEAR ON
- 4 AN ELECTION BALLOT WHO HAS NOT FILED THE AFFIDAVIT REQUIRED BY
- 5 THIS SECTION
- 6 (3) AS USED IN THIS SECTION
- 7 (A) "CHILD ABUSE" MEANS A VIOLATION OF SECTION 136B OR 145C
- 8 OF THE MICHIGAN PENAL CODE, ACT NO 328 OF THE PUBLIC ACTS OF
- 9 1931, BEING SECTIONS 750 136B AND 750 145C OF THE MICHIGAN
- 10 COMPILED LAWS, OR A VIOLATION OF A SIMILAR LAW OF THIS STATE,
- 11 ANOTHER STATE, OR THE UNITED STATES
- 12 (B) "FELONY" MEANS A VIOLATION OF A LAW OF THIS STATE,
- 13 ANOTHER STATE, OR THE UNITED STATES THAT IS PUNISHABLE BY IMPRIS-
- 14 ONMENT FOR MORE THAN ! YEAR
