## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 8 ballot question reside
- 9 (F) (e) Identification of the committee as a candidate
- 10 committee, political party committee, independent committee,
- 11 political committee, or ballot question committee if it is iden-
- 12 tifiable as such a committee
- 13 (3) AN INDEPENDENT OR POLITICAL COMMITTEE SHALL INCLUDE IN
- 14 THE NAME OF THE COMMITTEE THE NAME OF THE PERSON OR PERSONS THAT
- 15 SPONSOR THE COMMITTEE, IF ANY, OR WITH WHOM THE COMMITTEE IS
- 16 AFFILIATED A PERSON, OTHER THAN AN INDIVIDUAL OR A COMMITTEE,
- 17 SPONSORS OR IS AFFILIATED WITH AN INDEPENDENT OR POLITICAL COM-

- 19 Payment of a loan by a third party shall be recorded and reported

- 22 shall be reported as both contributions and expenditures A con-
- 23 tribution or expenditure -which THAT is by other than completed
