## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Act No 119 of the Public Acts of 1980, as
- 2 amended, being sections 207 211 to 207 235 of the Michigan
- 3 Compiled Laws, is amended by adding section 2a to read as
- 4 follows
- 5 SEC 2A (1) THE DEPARTMENT, ON BEHALF OF THIS STATE, MAY
- 6 ENTER INTO RECIPROCAL AGREEMENTS PROVIDING FOR THE IMPOSITION OF
- 7 MOTOR FUEL TAXES ON AN APPORTIONMENT OR ALLOCATION BASIS WITH THE
- 8 PROPER AUTHORITY OF ANY STATE, ANY COMMONWEALTH, THE DISTRICT OF
- 9 COLUMBIA, A STATE OR PROVINCE OF A FOREIGN COUNTRY, OR A

- 1 TERRITORY OR POSSESSION OF EITHER THE UNITED STATES OR OF A
- 2 FOREIGN COUNTRY
- 3 (2) TO IMPLEMENT THIS SECTION, THE DEPARTMENT MAY ENTER INTO
- 4 AND BECOME A MEMBER OF THE BASE STATE FUEL TAX AGREEMENT OR ANY
- 5 OTHER FUEL TAX AGREEMENT PLAN DEVELOPED BY THE NATIONAL GOVERNORS
- 6 ASSOCIATION
- 7 (3) THE DEPARTMENT MAY PROMULGATE RULES TO CARRY OUT AND
- 8 ENFORCE THE PROVISIONS OF THE BASE STATE FUEL TAX AGREEMENT OR
- 9 ANY OTHER AGREEMENT ENTERED INTO UNDER THIS SECTION RULES
- 10 PROMULGATED UNDER THIS SUBSECTION SHALL BE PROMULGATED PURSUANT
- 11 TO THE ADMINISTRATIVE PROCEDURES ACT OF 1969, ACT NO 306 OF THE
- 12 PUBLIC ACTS OF 1969, BEING SECTIONS 24 201 TO 24 328 OF THE
- 13 MICHIGAN COMPILED LAWS
- 14 (4) IF THE DEPARTMENT ENTERED INTO THE BASE STATE FUEL TAX
- 15 AGREEMENT OR INTO ANY OTHER AGREEMENT UNDER THIS SECTION, AND IF
- 16 THE PROVISIONS SET FORTH IN THAT AGREEMENT OR OTHER AGREEMENTS
- 17 ARE DIFFERENT FROM THIS ACT, THEN THE PROVISIONS OF THE AGREEMENT
- 18 SHALL CONTROL
- 19 (5) THIS SECTION CONSTITUTES COMPLETE AUTHORITY FOR THE
- 20 IMPOSITION OF MOTOR FUEL TAXES UPON AN APPORTIONMENT OR ALLOCA-
- 21 TION BASIS
