1 Section 1 Act No 152 of the Public Acts of 1979, as  
2 amended, being sections 338 2201 to 338 2277 of the Michigan  
3 Compiled Laws is amended by adding section 24 to read as  
4 follows

5 SEC 24 FEES FOR A PERSON LICENSED OR SEEKING LICENSURE AS  
6 A NATURAL HAIR CARE CULTURIST OR INSTRUCTOR, OR A PERSON LICENSED  
7 OR SEEKING LICENSURE TO OPERATE A NATURAL HAIR CULTURE SALON OR  
8 SCHOOL OF NATURAL HAIR CULTIVATION OR SEEKING A STUDENT  
9 REGISTRATION OR SEEKING A PERMIT TO CONDUCT AN APPRENTICESHIP
