THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Act No 281 of the Public Acts of 1967, as
- 2 amended, being sections 206 1 to 206 532 of the Michigan Compiled
- 3 Laws, is amended by adding section 274 to read as follows
- 4 SEC 274 (1) SUBJECT TO SUBSECTION (2), BEGINNING IN TAX
- 5 YEAR 1995 A TAXPAYER MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED
- 6 BY THIS ACT IN THE AMOUNT THE TAXPAYER PAYS FOR LEAD ABATEMENT,
- 7 REMOVAL, OR INTERIM CONTROL FOR EACH UNIT OF HOUSING THE TAXPAYER
- 8 OWNS OR RENTS, UP TO \$350 00 PER UNIT THE TAX CREDIT DESCRIBED
- 9 IN THIS SECTION OR ANY UNUSED PORTION OF THAT TAX CREDIT MAY BE
