



HOUSE BILL No. 5632

June 9 1994 Introduced by Rep Mathieu and referred to the Committee on Conservation Environment and Great Lakes

A bill to amend the title and sections 2 and 3 of Act No 22 of the Public Acts of 1984, entitled as amended Michigan civilian conservation corps act ' as amended by Act No 30 of the Public Acts of 1985, being sections 409 302 and 409 303 of the Michigan Compiled Laws and to add section 12a

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

1 Section 1 The title and sections 2 and 3 of Act No 22 of
2 the Public Acts of 1984, as amended by Act No 30 of the Public
3 Acts of 1985, being sections 409 302 and 409 303 of the Michigan
4 Compiled Laws, are amended and section 12a is added to read as
5 follows

4 Sec 3 ') The Michigan civilian conservation corps is
5 established JOINTLY within the department ~~of natural resources~~
6 AND THE COMMISSION for THE PURPOSE OF conserving, improving, and
7 developing this state s natural resources and for enhancing
8 preserving, and maintaining public lands and waters through the
9 employment of residents of this state in work training programs
0 The department may administer on a contractual basis a grant pro-
11 gram ~~which~~ THAT dispenses funds to recipients

12 (2) The work training programs required by this section and
13 section 5 shall provide work experience for certain residents of
14 this state that will increase their likelihood of obtaining
15 future employment

16 SEC 12A (1) THE MICHIGAN CIVILIAN CONSERVATION CORPS
17 ENDOWMENT FUND IS CREATED WITHIN THE STATE TREASURY

18 (2) THE STATE TREASURER MAY RECEIVE MONEY OR OTHER ASSETS
19 FROM ANY SOURCE FOR DEPOSIT INTO THE ENDOWMENT FUND THE STATE
20 TREASURER SHALL DIRECT THE INVESTMENT OF THE ENDOWMENT FUND THE
21 STATE TREASURER SHALL CREDIT TO THE ENDOWMENT FUND INTEREST AND
22 EARNINGS FROM ENDOWMENT FUND INVESTMENTS

23 (3) MONEY IN THE ENDOWMENT FUND AT THE CLOSE OF THE FISCAL
24 YEAR SHALL REMAIN IN THE ENDOWMENT FUND AND SHALL NOT LAPSE TO
25 THE GENERAL FUND

1 (4) THE DEPARTMENT WITH THE CONCURRENCE OF THE COMMISSION
2 SHALL EXPEND ONLY THE INTEREST AND EARNINGS OF THE ENDOWMENT FUND
3 FOR THE OPERATION OF THE CORPS
