being section 462 267 of the Michigan Compiled Laws

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Section 267 of Act No 354 of the Public Acts of
- 2 1993, being section 462 267 of the Michigan Compiled Laws is
- 3 amended to read as follows
- 4 Sec 267 (1) A RAILROAD COMPANY SHALL PLACE AND MAINTAIN
- 5 UPON EACH SWITCH A SIGNAL LIGHT OF SUFFICIENT CANDLEPOWER OR A
- 6 REFLECTORIZED SWITCH BANNER OF SUFFICIENT REFLECTIVE PROPERTIES
- 7 AND SO LOCATED THAT IT MAY BE SEEN FROM A DISTANCE OF 2,000 FEET,
- 8 UNDER NORMAL WEATHER CONDITIONS, ATTACHED IN A MANNER TO THE
- 9 MOVING PANEL OF THE SWITCH THAT IT WILL INDICATE SAFETY WHEN THE
- 10 SWITCH IS SET FOR THAT TRACK, AND WILL INDICATE DANGER WHEN THE

- 1 SWITCH IS NOT SET FOR THAT TRACK WHEN A SIGNAL LIGHT IS USED
- 2 IT SHALL BE KEPT BRIGHTLY BURNING CONSTANTLY BETWEEN THE HOURS OF
- 3 SUNSET AND SUNRISE AND ON SUCH DAYS OR PARTS OF DAYS AS WEATHER
- 4 CONDITIONS REQUIRE THIS SECTION SHALL NOT APPLY TO ANY SWITCH
- 5 THAT IS PRESENTLY LIGHTED BY ELECTRICITY OR THAT IS BOTH ELECTRI-
- 6 CALLY LOCKED AND LOCATED WITHIN THE LIMITS OF AN INTERLOCKING
- 7 PLANT OR CENTRALIZED TRAFFIC CONTROL TERRITORY OR AUTOMATIC BLOCK
- 8 TERRITORY
- 9 (2) A RAILROAD COMPANY OPERATING WHOLLY OR PARTLY IN THIS
- 10 STATE SHALL MAINTAIN A SIGNAL LIGHT OR BANNER, AS DESCRIBED IN
- 11 SUBSECTION (1), ATTACHED TO AND OPERATED BY THE MOVING PANEL OF
- 12 EVERY DERAIL SWITCH LOCATED IN THIS STATE THE LIGHT OR BANNER
- 13 SHALL BE ATTACHED TO THE DERAIL SWITCH AND SHALL BE IN PLAIN VIEW
- 14 OF ALL APPROACHING TRAINS WHEN A LIGHT IS USED, IT SHALL BE
- 15 KEPT BRIGHTLY BURNING CONSTANTLY BETWEEN THE HOURS OF SUNSET AND
- 16 SUNRISE AT EACH DERAILING DEVICE PLACED UPON OR OVER A TRACK OR
- 17 RAIL USED BY ANY RAILROAD COMPANY IN THIS STATE FOR THE PURPOSE
- 18 OF DERAILING CARS, TRAINS, OR PARTS OF TRAINS, THERE SHALL BE
- 19 PLACED AND MAINTAINED SUCH A LIGHT OR BANNER KEPT IN PLAIN VIEW
- 20 OF APPROACHING CARS, TRAINS, OR ENGINES, INDICATING AND SHOWING
- 21 THE LOCATION AND POSITION OF THE DERAILING DEVICE WHEN THIS
- 22 LIGHT IS USED, IT SHALL BE KEPT BURNING BRIGHTLY FROM SUNSET OF
- 23 EACH DAY UNTIL SUNRISE OF THE FOLLOWING DAY THIS SECTION SHALL
- 24 NOT APPLY TO A DERAILING DEVICE CONNECTED, MECHANICALLY OR OTHER-
- 25 WISE, WITH WHAT IS GENERALLY KNOWN AS THE HOME SIGNAL AT
- **26 INTERLOCKERS**

- 1 (3) ALL SWITCHES AND DERAILING DEVICES THAT ARE LIGHTED BY
- 2 ELECTRIC SIGNAL LIGHTS SHALL CONTINUE TO BE LIGHTED ELECTRICALLY
- 3 UNLESS THE DEPARTMENT DETERMINES THAT THE SAFETY OF EMPLOYEES AND
- 4 THE GENERAL PUBLIC NO LONGER REQUIRES THE USE OF AN ELECTRICALLY
- 5 LIGHTED SIGNAL LIGHT IF THE DEPARTMENT DETERMINES THAT THE
- 6 SAFETY OF EMPLOYEES AND THE GENERAL PUBLIC REQUIRES THE USE OF A
- 7 LIGHTED SIGNAL LIGHT ON ANY SWITCH OR DERAILING DEVICE WHERE A
- 8 REFLECTORIZED SWITCH BANNER HAS BEEN ESTABLISHED, THE DEPARTMENT
- 9 MAY ORDER THE INSTALLATION OF A LIGHTED SIGNAL LIGHT
- 10 (4) (1) A person not authorized by a railroad company
- 11 shall not destroy, remove, change, extinguish, or tamper with in
- 12 any manner, any light or banner attached to or connected with any
- 13 switch or derailing device maintained by a railroad company
- 14 (5) $\frac{(2)}{}$ A person who violates this section is guilty of a
- 15 misdemeanor, punishable by a fine of not less than \$100 00, or
- 16 more than \$500 00, or by imprisonment for not less than 10 days
- 17 or more than 60 days
