

## HOUSE BILL No. 5765

September 14 1994 Introduced by Reps Shugars and Jaye and referred to the Committee on Public Health

A bill to amend section 3 of Act No 116 of the Public Acts of 1973, entitled

An act to provide for the protection of children through the licensing and regulation of child care organizations to provide for the establishment of standards of care for child care organizations to provide penalties and to repeal certain acts and parts of acts '

as amended by Act No 232 of the Public Acts of 1980, being section 722 113 of the Michigan Compiled Laws

- 8 PAROCHIAL SCHOOL BUILDING, IN WHICH CARE IS PROVIDED TO
- 9 SCHOOL-AGE CHILDREN FOR PERIODS OF LESS THAN 24 HOURS A DAY
- 10 EITHER BEFORE OR AFTER SCHOOL, THAT MEETS THE HEALTH AND FIRE
- 11 SAFETY REQUIREMENTS PRESCRIBED BY THE SCHOOL CODE OF 1976, ACT
