A bill to amend Act No 218 of the Public Acts of 1956, entitled as amended

The insurance code of 1956,'

as amended, being sections 500 100 to 500 8302 of the Michigan Compiled Laws, by adding section 2240

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Act No 218 of the Public Acts of 1956, as
- 2 amended being sections 500 100 to 500 8302 of the Michigan
- 3 Compiled Laws, is amended by adding section 2240 to read as
- 4 follows
- 5 SEC 2240 (1) EACH DISABILITY INSURER AND EACH SELF-FUNDED
- 6 HEALTH PLAN SHALL REQUIRE THAT ONLY THE STANDARD MEDICAL CLAIM
- 7 FORM ESTABLISHED PURSUANT TO SUBSECTION (2) BE USED BEFORE A
- 8 CLAIM IS PAID

- 1 (2) THE COMMISSIONER SHALL PROMULGATE RULES PURSUANT TO THE
- 2 ADMINISTRATIVE PROCEDURES ACT OF 1969, ACT NO 306 OF THE PUBLIC
- 3 ACTS OF 1969, BEING SECTIONS 24 201 TO 24 328 OF THE MICHIGAN
- 4 COMPILED LAWS, ESTABLISHING, IN PLAIN ENGLISH, A STANDARD MEDICAL
- 5 CLAIM FORM TO BE USED BY EACH DISABILITY INSURER, SELF-FUNDED
- 6 HEALTH PLAN, HEALTH CARE CORPORATION, AND HEALTH MAINTENANCE
- 7 ORGANIZATION THE STANDARD MEDICAL CLAIM FORM SHALL REQUIRE PRO-
- 8 VIDERS TO LIST EACH PROCEDURE AND SERVICE PERFORMED PURSUANT TO
- 9 THE CODE IDENTIFIED FOR THAT PROCEDURE OR SERVICE IN THE INTERNA-
- 10 TIONAL CLASSIFICATION OF CLINICAL SERVICES BY THE COMMISSION ON
- 11 PROFESSIONAL AND HOSPITAL ACTIVITIES
- 12 (3) ALL BILLING FOR HEALTH CLAIMS FOR A DISABILITY INSURER
- 13 OR SELF-FUNDED HEALTH PLAN SHALL BE DONE THROUGH REGIONAL CLAIMS
- 14 CENTERS TO REDUCE ADMINISTRATIVE EXPENSES
- 15 (4) THE FIRST OF THE FOLLOWING ENTITIES TO RECEIVE A HEALTH
- 16 CARE CLAIM IS RESPONSIBLE FOR COORDINATING THE REIMBURSEMENT FOR
- 17 THAT CLAIM WITH ANY OTHER OF THE FOLLOWING ENTITIES THAT MAY BE
- 18 RESPONSIBLE FOR THAT CLAIM
- 19 (A) AN INSURER
- 20 (B) A SELF-FUNDED HEALTH PLAN
- 21 (C) A HEALTH CARE CORPORATION
- 22. (D) A HEALTH MAINTENANCE ORGANIZATION
- 23 (E) THE MEDICAL SERVICES ADMINISTRATION OF THE DEPARTMENT OF
- 24 SOCIAL SERVICES
- 25 (5) THIS SECTION SHALL TAKE EFFECT OCTOBER 1, 1995
