THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- Section 1 Act No 368 of the Public Acts of 1978, as
- 2 amended, being sections 333 1101 to 333 25211 of the Michigan
- 3 Compiled Laws, is amended by adding section 21053a to read as
- 4 follows
- 5 SEC 21053A (1) EACH HEALTH MAINTENANCE ORGANIZATION SHALL
- 6 REQUIRE THAT ONLY THE STANDARD MEDICAL CLAIM FORM ESTABLISHED IN
- 7 SECTION 2240 OF THE INSURANCE CODE OF 1956, ACT NO 218 OF THE
- 8 PUBLIC ACTS OF 1956, BEING SECTION 500 2240 OF THE MICHIGAN
- 9 COMPILED LAWS, SHALL BE USED BEFORE A CLAIM IS PAID

- 1 (2) EACH HEALTH MAINTENANCE ORGANIZATION SHALL REQUIRE
- 2 PROVIDERS TO LIST ON THE STANDARD MEDICAL CLAIM FORM EACH
- 3 PROCEDURE AND SERVICE PERFORMED PURSUANT TO THE CODE IDENTIFIED
- 4 FOR THAT PROCEDURE OR SERVICE IN THE INTERNATIONAL CLASSIFICATION

- 7 (3) ALL BILLING FOR CLAIMS FOR A HEALTH MAINTENANCE ORGANI-

- 10 (4) THE FIRST OF THE FOLLOWING ENTITIES TO RECEIVE A HEALTH
- 11 CARE CLAIM IS RESPONSIBLE FOR COORDINATING THE REIMBURSEMENT FOR
- 12 THAT CLAIM WITH ANY OTHER OF THE FOLLOWING ENTITIES THAT MAY BE

- 14 (A) AN INSURER
- 15 (B) A SELF-FUNDED HEALTH PLAN
- 16 (C) A HEALTH CARE CORPORATION
