



HOUSE BILL No. 5800

September 14 1994, Introduced by Reps Cropsey, McNutt, LeTarte Weeks Freeman, Clack, Schroer, Lowe, Pitoniak and Galloway and referred to the Committee on Corrections

A bill to amend section 63a of Act No 232 of the Public Acts of 1953 entitled

An act to revise, consolidate, and codify the laws relating to probationers and probation officers, to pardons, reprieves commutations and paroles to the administration of correctional institutions correctional farms, and probation recovery camps to prisoner labor and correctional industries, and to the supervision and inspection of local jails and houses of correction to provide for the siting of correctional facilities to create a state department of corrections and to prescribe its powers and duties to provide for the transfer to and vesting in said department of powers and duties vested by law in certain other state boards commissions, and officers and to abolish certain boards commissions and offices the powers and duties of which are transferred by this act to prescribe the powers and duties of certain other state departments and agencies to provide for the creation of a local lockup advisory board to prescribe penalties for the violation of the provisions of this act to make certain appropriations to repeal certain parts of this act on specific dates and to repeal all acts and parts of acts inconsistent with the provisions of this act

being section 791 263a of the Michigan Compiled Laws

THE PEOPLE OF THE STATE OF MICHIGAN ENACT

1 Section 1 Section 63a of Act No 232 of the Public Acts of

 11 begin and then shall receive in addition to ~~workmen's~~ WORKER S
 12 compensation benefits a supplement from the department which
 13 together with the ~~workmen's~~ WORKER S compensation benefits
 14 shall equal but not exceed the weekly net wage of the employee at
 15 the time of the injury This supplement shall only apply while
 16 the person is on the department s payroll and is receiving
 17 ~~workmen's~~ WORKER S compensation benefits and shall include an
 18 employee who is currently receiving ~~workmen's~~ WORKER S compen-
 19 sation due to an injury covered by this section Fringe benefits
 20 normally received by an employee shall be in effect during the
 21 time the employee receives the supplement provided by this sec-
 22 tion from the department

23 ~~-(2) For purposes of this section "penal institution"~~
 24 ~~includes the state prison of southern Michigan in the township of~~
 25 ~~Blackman, the county of Jackson the state house of correction~~
 26 ~~and branch of state prison at Marquette in the county of~~
 27 ~~Marquette the Michigan reformatory at Ionia in the county of~~
