## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

- 1 Section 1 Act No 280 of the Public Acts of 1939, as
- 2 amended, being sections 400 1 to 400 119b of the Michigan
- 3 Compiled Laws, is amended by adding section 56h to read as
- 4 follows
- 5 SEC 56H (1) THE DEPARTMENT SHALL IMPLEMENT A PROGRAM FOR
- 6 RECIPIENTS OF AID TO FAMILIES WITH DEPENDENT CHILDREN AND STATE
- 7 FAMILY ASSISTANCE THAT PERMITS A HOUSEHOLD RECEIVING ASSISTANCE
- 8 TO ESTABLISH AN IRREVOCABLE EDUCATION ACCOUNT IN AN AMOUNT UP TO
- 9 \$5,000 00 TO PROVIDE FOR EDUCATIONAL EXPENSES OF MEMBERS OF THE

- 1 HOUSEHOLD THE DEPARTMENT SHALL NOT CONSIDER MONEY DEPOSITED IN
