- 6 to section 728 of the Michigan vehicle code Act No 300 of the

- 9 (c) To fix bail and accept bond in all cases
- (d) To issue search warrants when authorized to do so by a
- 11 district court judge
- (2) AUTHORIZATION UNDER SUBSECTION (1)(A) OR (D) MAY BE A
- 13 GENERAL AUTHORIZATION TO PERFORM THAT FUNCTION RATHER THAN A SPE-
- 14 CIFIC AUTHORIZATION TO ACT IN AN INDIVIDUAL CASE
- 15 Section 2 This amendatory act shall not take effect unless
- 16 Senate Bill No ____ or House Bill No _5964 (request
- 17 no 05808 94 a) of the 87th Legislature is enacted into law
