December 7 1994, Introduced by Rep Galloway and referred to the Committee on Judiciary

A bill to amend section 8123 of Act No 236 of the Public Acts of 1961, entitled as amended

'Revised judicature act of 1961,"

as amended by Act No 54 of the Public Acts of 1990, being section 600 8123 of the Michigan Compiled Laws

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT

1 Section 1 Section 8123 of Act No 236 of the Public Acts  
2 of 1961, as amended by Act No 54 of the Public Acts of 1990,  
3 being section 600 8123 of the Michigan Compiled Laws, is amended  
4 to read as follows

5 Sec 8123 (1) The forty-third district consists of the  
6 cities of Madison Heights, Ferndale, and Hazel Park, is a dis-  
7 trict of the third class, and has 3 judges Subject to either  
8 section 8177 or 8178, this district shall be consolidated with

1 the fifty-second district and become the fifth division effective  
2 ~~January 2, 1991~~ AS PROVIDED IN SECTIONS 8177 AND 8178

3 (2) The forty-fourth district consists of the city of Royal  
4 Oak, is a district of the third class, and has 2 judges

5 (3) The forty-fifth-a district consists of the city of  
6 Berkley, is a district of the third class, and has 1 judge  
7 Subject to either section 8177 or 8178, this district shall be  
8 consolidated with the fifty-second district and become the sixth  
9 division effective ~~January 2, 1991~~ AS PROVIDED IN SECTIONS 8177  
10 AND 8178

11 (4) The forty-fifth-b district consists of the cities of  
12 Huntington Woods, Oak Park, and Pleasant Ridge and the township  
13 of Royal Oak in the county of Oakland, is a district of the third  
14 class, and has 2 judges Subject to either section 8177 or 8178,  
15 this district shall be consolidated with the fifty-second dis-  
16 trict and become the seventh division effective ~~January 1, 1991~~  
17 AS PROVIDED IN SECTIONS 8177 AND 8178

18 (5) The forty-sixth district consists of the cities of  
19 Southfield and Lathrup Village and the township of Southfield in  
20 the county of Oakland, is a district of the third class and has  
21 3 judges

22 (6) The forty-seventh district consists of the cities of  
23 Farmington and Farmington Hills, is a district of the third  
24 class, and has 2 judges ~~Subject to section 8175, this district~~  
25 ~~may have 1 additional judge effective January 1, 1991~~ If a new  
26 ~~office of judge is added to this district to be filled by~~

~~1 election in 1990 the term of office of the judge for that~~  
~~2 election only shall be 4 years~~

3 (7) The forty-eighth district consists of the cities of  
4 Birmingham, Bloomfield Hills, Sylvan Lake, Keego Harbor, and  
5 Orchard Lake Village and the townships of Bloomfield and West  
6 Bloomfield in the county of Oakland, is a district of the third  
7 class, and has 3 judges ~~Subject to section 8-175, this district~~  
8 ~~may have 1 additional judge effective January 1, 1993~~

9 (8) The fiftieth district consists of the city of Pontiac,  
10 is a district of the third class, and has 4 judges

11 (9) The fifty-first district consists of the township of  
12 Waterford in the county of Oakland, is a district of the third  
13 class, and has 2 judges

14 (10) Except as otherwise provided by this subsection the  
15 fifty-second district consists of the county of Oakland except  
16 the cities of Madison Heights, Ferndale, Hazel Park, Royal Oak,  
17 Berkley, Huntington Woods, Oak Park, Pleasant Ridge, Southfield,  
18 Lathrup Village, Farmington, Farmington Hills, Northville, Sylvan  
19 Lake Keego Harbor Orchard Lake Village Birmingham Bloomfield  
20 Hills, and Pontiac and the townships of Royal Oak, Southfield,  
21 West Bloomfield, Bloomfield, and Waterford, is a district of the  
22 second class, and is divided into the following election  
23 divisions

24 (a) The first division consists of the cities of Novi, South  
25 Lyon, Wixom, and Walled Lake and the townships of Milford,  
26 Highland, Rose, ~~White Lake,~~ Commerce, Lyon, and Novi and has 3

1 judges ~~Subject to section 8175 this division may have 1~~  
2 ~~additional judge effective January 1, 1991~~

3 (b) The second division consists of the townships of  
4 Springfield, Independence, Holly, Groveland, WHITE LAKE, and  
5 Brandon and has 1 judge

6 (c) The third division consists of the cities of Rochester,  
7 Auburn Hills, Rochester Hills, and Lake Angelus and the townships  
8 of Oxford, Addison, Orion and Oakland and has ~~2~~ 3 judges  
9 ~~Subject to section 8175, this division may have 1 additional~~  
10 ~~judge effective January 2, 1989~~

11 (d) The fourth division consists of the cities of Troy and  
12 Clawson and has 3 judges

13 (e) Subject to either section 8177 or 8178, ~~effective~~  
14 ~~January 1, 1991,~~ the fifth division shall consist of the cities  
15 of Madison Heights, Ferndale, and Hazel Park, and have 3 judges

16 (f) Subject to either section 8177 or 8178, ~~effective~~  
17 ~~January 2, 1991,~~ the sixth division shall consist of the city of  
18 Berkley, and have 1 judge

19 (g) Subject to either section 8177 or 8178, ~~effective~~  
20 ~~January 2, 1991,~~ the seventh division shall consist of the  
21 cities of Huntington Woods, Oak Park, and Pleasant Ridge and the  
22 township of Royal Oak in the county of Oakland, and have 2  
23 judges
