

SENATE BILL No. 13

January 13, 1993, Introduced by Senator DI NELLO and referred to the Committee on State Affairs and Military/Veteran Affairs.

A bill to amend section 4 of Act No. 300 of the Public Acts of 1974, entitled

"Motor vehicle service and repair act," as amended by Act No. 151 of the Public Acts of 1980, being section 257.1304 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 4 of Act No. 300 of the Public Acts of
- 2 1974, as amended by Act No. 151 of the Public Acts of 1980, being
- 3 section 257.1304 of the Michigan Compiled Laws, is amended to
- 4 read as follows:
- 5 Sec. 4. Unless the act or practice of repairing, servicing,
- 6 reconditioning, or engaging in the activity of a master or spe-
- 7 cialty mechanic is adopted for the purposes of evading this act,
- 8 this act shall not apply to a person who:

- 1 (a) Repairs, replaces, reconditions, adjusts, analyzes,
- 2 diagnoses, or alters the operating condition of his or her own or
- 3 a family member's motor vehicle and for which there is evidence
- 4 of ownership of that motor vehicle.
- 5 (b) Is a master or specialty mechanic, a motor vehicle
- 6 mechanic, a mechanic trainee, or technician who is in the
- 7 full-time employ of an automotive manufacturer and is engaged
- 8 solely in that capacity on motor vehicles owned by or being
- 9 produced by the manufacturer.
- 10 (c) Engages solely in the business of repairing the motor
- 11 vehicles for compensation of a single commercial, industrial, or
- 12 governmental establishment, or 2 or more establishments related
- 13 by common ownership or corporate affiliation, EXCEPT FOR A PERSON
- 14 WHO REPAIRS SCHOOL BUSES PURSUANT TO SECTION 38 OF THE PUPIL
- 15 TRANSPORTATION ACT, ACT NO. 187 OF THE PUBLIC ACTS OF 1990, BEING
- 16 SECTION 257.1838 OF THE MICHIGAN COMPILED LAWS.
- (d) Engages solely in the business of repairing, replacing,
- 18 reconditioning, adjusting, analyzing, diagnosing, or altering the
- 19 operating condition of a motor vehicle or trailer not required to
- 20 be registered and not titled under THE MICHIGAN VEHICLE CODE, Act
- 21 No. 300 of the Public Acts of 1949, as amended, being sections
- 22 257.1 to 257.923 of the Michigan Compiled Laws. The state trea-
- 23 surer shall reimburse a person exempted under this subdivision
- 24 money paid by the person as a registration fee or renewal regis-
- 25 tration fee under section 30.
