

## SENATE BILL No. 60

January 13, 1993, Introduced by Senator WARTNER and referred to the Committee on Natural Resources and Environmental Affairs.

A bill to amend section 261 of Act No. 431 of the Public Acts of 1984, entitled as amended
"The management and budget act,"
as amended by Act No. 504 of the Public Acts of 1988, being section 18.1261 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 261 of Act No. 431 of the Public Acts of
- 2 1984, as amended by Act No. 504 of the Public Acts of 1988, being
- 3 section 18.1261 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 261. (1) The department shall provide for the purchase
- 6 of, -or the contracting for, AND the providing of supplies,
- 7 materials, services, insurance, utilities, third party financing,
- 8 equipment, printing, and all other items as needed by state
- 9 agencies for which the legislature has not otherwise expressly

- 1 provided. In all purchases made by the department, all other
- 2 things being equal, preference shall be given to products manu-
- 3 factured or services offered by Michigan-based firms, -where- IF
- 4 MICHIGAN GOODS OR SERVICES ARE NOT AVAILABLE, PREFERENCE SHALL BE
- 5 GIVEN TO PRODUCTS MANUFACTURED OR SERVICES OFFERED BY FIRMS BASED
- 6 IN THE UNITED STATES OF AMERICA, IF consistent with federal
- 7 statutes. The department shall solicit competitive bids from the
- 8 private sector whenever practicable to efficiently and effec-
- 9 tively meet the state's needs. The department shall first deter-
- 10 mine that competitive solicitation of bids in the private sector
- 11 is not appropriate before it shall use any other procurement
- 12 method for an acquisition.
- 13 (2) The department shall make all discretionary decisions
- 14 concerning the solicitation, award, amendment, cancellation, and
- 15 appeal of state contracts.
- 16 (3) The department shall utilize competitive bidding for all
- 17 purchases authorized pursuant to subsection (1) unless the
- 18 department has determined that another procurement method is in
- 19 the state's best interests.
- 20 (4) The department may delegate its procurement authority to
- 21 other state agencies within dollar limitations and for designated
- 22 types of procurements. The department may withdraw delegated
- 23 authority upon a finding that a state agency did not comply with
- 24 departmental procurement directives.
- 25 (5) The department may enter into lease purchases or
- 26 installment purchases for periods not exceeding the anticipated

- 1 useful life of the items purchased unless otherwise prohibited by 2 law.
- 3 (6) The department shall issue directives for the procure-
- 4 ment, receipt, inspection, and storage of supplies, materials,
- 5 and equipment, and for printing and services needed by state
- 6 agencies. The department shall provide standard specifications
- 7 and standards of performance applicable to purchases.
- 8 (7) THE DEPARTMENT MAY ENTER INTO A COOPERATIVE PURCHASING
- 9 AGREEMENT WITH 1 OR MORE OTHER STATES OR PUBLIC ENTITIES FOR THE
- 10 PURCHASE OF GOODS, INCLUDING, BUT NOT LIMITED TO, RECYCLED GOODS,
- 11 AND SERVICES NECESSARY FOR STATE PROGRAMS.
