

SENATE BILL No. 105

January 13, 1993, Introduced by Senator DI NELLO and referred to the Committee on Local Government and Urban Development.

A bill to amend section 3 of Act No. 317 of the Public Acts of 1968, entitled as amended

"An act relating to the conduct of public servants in respect to governmental decisions and contracts with public entities; to provide penalties for the violation of this act; to repeal certain acts and parts of acts; and to validate certain contracts,"

as amended by Act No. 184 of the Public Acts of 1984, being section 15.323 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 3 of Act No. 317 of the Public Acts of
- 2 1968, as amended by Act No. 184 of the Public Acts of 1984, being
- 3 section 15.323 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 3. (1) -Section EXCEPT AS PROVIDED IN THIS SECTION,
- 6 SECTION 2 -shall- DOES not apply to either of the following:

- (a) A public servant who is paid for working an average of25 hours per week or less for a public entity.
- 3 (b) A public servant who is an employee of a public commu-
- 4 nity college, junior college, or state college or university.
- 5 (2) A contract as defined in and limited by section 2
- 6 involving a public entity and a public servant described in sub-
- 7 section (1) shall meet all of the following requirements:
- 8 (a) The public servant promptly discloses any pecuniary
- 9 interest in the contract to the official body -which THAT has
- 10 power to approve the contract, which disclosure shall be made a
- 11 matter of record in its official proceedings.
- 12 (b) The contract is approved by a vote of not less than 2/3
- 13 of the full membership of the -approving- OFFICIAL body in open
- 14 session without the vote of the public servant making the
- 15 disclosure.
- 16 (c) The official body discloses the following summary infor-
- 17 mation in its official minutes:
- (i) The name of each party involved in the contract.
- 19 (ii) The terms of the contract, including duration, finan-
- 20 cial consideration between parties, facilities or services of the
- 21 public entity included in the contract, and the nature and degree
- 22 of assignment of employees of the public entity for fulfillment
- 23 of the contract.
- 24 (iii) The nature of any pecuniary interest.
- 25 (3) This section and section 2 -shall DO not prevent a
- 26 public servant from making or participating in making a
- 27 governmental decision to the extent that the public servant's

- 1 participation is required by law. If 2/3 of the members are not
- 2 eligible under this act to vote on a contract or to constitute a
- 3 quorum, a member may be counted for purposes of a quorum and may
- 4 vote on the contract if the member will directly benefit from the
- 5 contract in an amount less than \$250.00 and less than 5% of the
- 6 public cost of the contract and IF the member files a sworn affi-
- 7 davit to that effect with the official body. The affidavit shall
- 8 be made a part of the public record of the official proceedings.
- 9 As used in this subsection, "governmental decision" means a
- 10 determination, action, vote, or disposition upon a motion, pro-
- 11 posal, recommendation, resolution, ordinance, order, or measure
- 12 on which a vote by members of a local legislative or governing
- 13 body of a public entity is required and by which a public body
- 14 effectuates or formulates public policy.
- 15 (4) AN ELECTED OFFICIAL OF A UNIT OF LOCAL GOVERNMENT SHALL
- 16 NOT SIMULTANEOUSLY SERVE AS A BARGAINING REPRESENTATIVE OF A
- 17 LABOR ORGANIZATION WITH WHICH THAT UNIT OF LOCAL GOVERNMENT
- 18 BARGAINS.
