

SENATE BILL No. 163

January 26, 1993, Introduced by Senator BOUCHARD and referred to the Committee on Education.

A bill to amend Act No. 148 of the Public Acts of 1943, entitled as amended

"An act to provide for the regulation and licensing of proprietary schools in the state; to require surety; to provide for collection and disposition of fees; and to prescribe penalties for the violation of this act,"

as amended, being sections 395.101 to 395.103 of the Michigan Compiled Laws, by adding section 2c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 148 of the Public Acts of 1943, as
- 2 amended, being sections 395.101 to 395.103 of the Michigan
- 3 Compiled Laws, is amended by adding section 2c to read as
- 4 follows:
- 5 SEC. 2C. (1) A PROPRIETARY SCHOOL SHALL MAKE AND MAINTAIN
- 6 FOR EACH STUDENT AN ACADEMIC RECORD AND TRANSCRIPT, SHOWING AT
- 7 LEAST COURSES TAKEN, GRADES EARNED, AND CERTIFICATES OR DEGREES

- 1 AWARDED. UPON REQUEST BY THE STUDENT, A PROPRIETARY SCHOOL SHALL
- 2 MAKE AVAILABLE TO THE STUDENT HIS OR HER ACADEMIC RECORD AND
- 3 TRANSCRIPT.
- 4 (2) A PROPRIETARY SCHOOL SHALL NOT DISCONTINUE ITS OPERA-
- 5 TIONS, CEASE INSTRUCTION, OR SURRENDER ITS LICENSE UNLESS IT PRO-
- 6 VIDES TO THE DEPARTMENT OF EDUCATION AT LEAST 30 DAYS BEFORE THE
- 7 DATE OF THAT ACTION WRITTEN NOTICE OF ITS INTENTION TO TAKE THAT
- 8 ACTION AND A PLAN FOR SAFELY SECURING THE ACADEMIC RECORDS AND
- 9 TRANSCRIPTS OF THE PROPRIETARY SCHOOL AND TRANSFERRING THOSE DOC-
- 10 UMENTS TO THE DEPARTMENT OF EDUCATION. HOWEVER, THE DEPARTMENT
- 11 OF EDUCATION MAY WAIVE THE 30-DAYS' NOTICE REQUIREMENT FOR GOOD
- 12 CAUSE.
- 13 (3) UPON CEASING INSTRUCTION, A PROPRIETARY SCHOOL PROMPTLY
- 14 SHALL PROVIDE TO THE DEPARTMENT OF EDUCATION PURSUANT TO THE PLAN
- 15 SUBMITTED UNDER SUBSECTION (2) THE ORIGINAL OR A COPY OF THE ACA-
- 16 DEMIC RECORD AND TRANSCRIPT OF EACH STUDENT THAT HAS ATTENDED THE
- 17 PROPRIETARY SCHOOL.
- 18 (4) THE DEPARTMENT SHALL PERMANENTLY MAINTAIN ACADEMIC
- 19 RECORDS AND TRANSCRIPTS RECEIVED UNDER SUBSECTION (3) AND, UPON
- 20 WRITTEN REQUEST BY A STUDENT, SHALL MAKE AVAILABLE TO THE STUDENT
- 21 HIS OR HER ACADEMIC RECORD AND TRANSCRIPT.
