

SENATE BILL No. 178

January 26, 1993, Introduced by Senator BOUCHARD and referred to the Committee on Family Law, Criminal Law, and Corrections.

A bill to amend Act No. 266 of the Public Acts of 1929, entitled as amended

"An act to protect the health, and promote the safety and welfare of the people, by regulating the installation, alteration, maintenance, improvement and inspection of plumbing; to define plumbing and the classification of plumbers; to provide for the issuing of licenses and permits pertaining thereto and the disposition of moneys derived therefrom; to create a plumbing board, and to prescribe its powers and duties; to authorize cities, villages and townships to adopt and enforce certain standards; to establish remedies and fix penalties for violation of the provisions of this act,"

as amended, being sections 338.901 to 338.917 of the Michigan Compiled Laws, by adding section 11c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 266 of the Public Acts of 1929, as
- 2 amended, being sections 338.901 to 338.917 of the Michigan
- 3 Compiled Laws, is amended by adding section 11c to read as
- 4 follows:

- 1 SEC. 11C. (1) SUBJECT TO SUBSECTION (2), UPON RECEIPT OF A
- 2 NOTICE FROM THE OFFICE OF THE FRIEND OF THE COURT STATING THAT AN
- 3 INDIVIDUAL LICENSEE IS AT LEAST 3 MONTHS IN ARREARS OF SUPPORT,
- 4 THE PLUMBING BOARD SHALL SUSPEND THE LICENSE OF AN INDIVIDUAL
- 5 AFTER ALL OF THE FOLLOWING OCCUR:
- 6 (A) THE DEPARTMENT SENDS A NOTICE FOR A HEARING TO BE SCHED-
- 7 ULED NOT LESS THAN 30 DAYS AFTER THE DATE THE NOTICE IS SENT TO
- 8 THE INDIVIDUAL'S ADDRESS AS INDICATED IN THE DEPARTMENT'S
- 9 RECORDS.
- 10 (B) THE LICENSEE FAILS TO PRESENT PROOF ACCEPTABLE TO THE
- 11 PLUMBING BOARD THAT THE ARREARAGE HAS BEEN PAID OR THAT A REPAY-
- 12 MENT SCHEDULE IS IN EFFECT.
- 13 (2) IF AT THE HEARING THE PLUMBING BOARD DETERMINES THAT
- 14 EXTREME HARDSHIP TO THE INDIVIDUAL OR PERSONS THE INDIVIDUAL
- 15 SERVES WOULD BE CREATED BY THE SUSPENSION, THE PLUMBING BOARD
- 16 SHALL NOT SUSPEND THE LICENSE AND SHALL CONDITION THE HOLDING OF
- 17 THE LICENSE UPON COMPLIANCE WITH THE SUPPORT ORDER.
- 18 (3) THE ONLY ISSUES TO BE CONSIDERED BY THE PLUMBING BOARD
- 19 ARE WHETHER THE INDIVIDUAL IS THE HOLDER OF A LICENSE AND WHETHER
- 20 THE INDIVIDUAL HAS PRESENTED PROOF ACCEPTABLE TO THE PLUMBING
- 21 BOARD THAT THE ARREARAGE HAS BEEN PAID OR THAT A REPAYMENT SCHED-
- 22 ULE IS IN EFFECT.
- 23 Section 2. This amendatory act shall not take effect unless
- 24 Senate Bill No. 173
- of the 87th Legislature is enacted into law.
