

SENATE BILL No. 318

February 2, 1993, Introduced by Senators CHERRY, EHLERS, ARTHURHULTZ, KOIVISTO, DINGELL, SCHWARZ, KELLY, BERRYMAN, HART, O'BRIEN and EMMONS and referred to the Committee on Transportation and Tourism.

A bill to amend Act No. 300 of the Public Acts of 1949, entitled as amended

"Michigan vehicle code,"

as amended, being sections 257.1 to 257.923 of the Michigan Compiled Laws, by adding section 811c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 300 of the Public Acts of 1949, as
- 2 amended, being sections 257.1 to 257.923 of the Michigan Compiled
- 3 Laws, is amended by adding section 811c to read as follows:
- 4 SEC. 811C. (1) THE SECRETARY OF STATE SHALL INITIATE A CON-
- 5 TEST FOR MICHIGAN CITIZENS FOR THE PURPOSE OF CREATING THE DESIGN
- 6 FOR A GREAT LAKES WATER QUALITY REGISTRATION PLATE. AFTER SELEC-
- 7 TION OF THE APPROPRIATE DESIGN, THE SECRETARY OF STATE SHALL
- 8 DEVELOP A GREAT LAKES WATER QUALITY PLATE AND, UPON APPLICATION,
- 9 SHALL ISSUE A GREAT LAKES WATER QUALITY PLATE TO AN APPLICANT FOR

- 1 USE ON THE PASSENGER MOTOR VEHICLE, PICKUP TRUCK, VAN, OR MOTOR
- 2 HOME FOR WHICH THE PLATE IS ISSUED INSTEAD OF A STANDARD REGIS-
- 3 TRATION PLATE.
- 4 (2) AN APPLICATION FOR A GREAT LAKES WATER QUALITY PLATE
- 5 SHALL BE SUBMITTED TO THE SECRETARY OF STATE PURSUANT TO THE PRO-
- 6 CEDURES PRESCRIBED IN SECTION 217. IN ADDITION TO THE REGULAR
- 7 REGISTRATION TAX IMPOSED BY SECTION 801, EACH APPLICATION SHALL
- 8 BE ACCOMPANIED WITH PAYMENT OF A SERVICE FEE OF \$5.00 FOR THE
- 9 FIRST MONTH AND \$2.00 PER MONTH FOR EACH ADDITIONAL MONTH OF THE
- 10 REGISTRATION PERIOD OF THE PLATE. GREAT LAKES WATER QUALITY
- 11 PLATES SHALL EXPIRE ON THE APPLICANT'S BIRTHDAY PURSUANT TO
- 12 SECTION 226.
- 13 (3) THE GREAT LAKES WATER QUALITY FUND IS CREATED AS A
- 14 RESTRICTED FUND IN THE STATE TREASURY. MONEY IN THE FUND SHALL
- 15 BE EXPENDED ONLY AS PROVIDED IN THIS SECTION.
- 16 (4) THE SECRETARY OF STATE SHALL DEPOSIT EACH SERVICE FEE
- 17 COLLECTED PURSUANT TO THIS SECTION WITH THE STATE TREASURER, TO
- 18 THE CREDIT OF THE GREAT LAKES WATER QUALITY FUND. THE FUND MAY
- 19 RECEIVE MONEY FROM ANY OTHER SOURCE AS APPROPRIATED BY THE
- 20 LEGISLATURE. THE MONEY IN THE FUND, AFTER DEDUCTING THE ADMINIS-
- 21 TRATIVE COSTS TO THE STATE, SHALL, UPON APPROPRIATION, BE USED TO
- 22 ASSIST IN GREAT LAKES PROTECTION EFFORTS SUCH AS COMBINED SEWER
- 23 OVERFLOWS AND NONPOINT SOURCES OF WATER POLLUTION.
- 24 (5) THE SECRETARY OF STATE MAY ISSUE A TEMPORARY REGISTRA-
- 25 TION PERMIT TO A PERSON WHO SUBMITS AN APPLICATION AND THE PROPER
- 26 PAYMENTS FOR A GREAT LAKES WATER QUALITY PLATE, IF THE
- 27 APPLICANT'S CURRENT VEHICLE REGISTRATION WILL EXPIRE BEFORE HIS

- 1 OR HER RECEIPT OF A GREAT LAKES WATER QUALITY PLATE. THE
- 2 TEMPORARY REGISTRATION SHALL EXPIRE UPON RECEIPT OF A GREAT LAKES
- 3 WATER QUALITY PLATE OR 60 DAYS AFTER THE ISSUANCE, WHICHEVER
- 4 OCCURS FIRST. THE TEMPORARY PERMIT SHALL BE ISSUED WITHOUT A
- 5 SEPARATE FEE.
