

## **SENATE BILL No. 330**

February 3, 1993, Introduced by Senators CHERRY, BERRYMAN, DUNASKISS, GAST, CARL and KOIVISTO and referred to the Committee on State Affairs and Military/Veteran Affairs.

A bill to amend section 2012 of Act No. 299 of the Public Acts of 1980, entitled as amended "Occupational code," as amended by Act No. 103 of the Public Acts of 1992, being section 339.2012 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Section 2012 of Act No. 299 of the Public Acts
- 2 of 1980, as amended by Act No. 103 of the Public Acts of 1992,
- 3 being section 339.2012 of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- Sec. 2012. The following persons are exempt from the
- 6 requirements of this article:
- (a) A professional engineer employed by a railroad or other
- 8 interstate corporation whose employment and practice is
- 9 confined to the property of the corporation.

- 1 (b) A designer of a manufactured product -, if the
- 2 manufacturer of the product assumes responsibility for the qual-
- 3 ity of the product.
- 4 (c) An owner doing architectural, engineering, or surveying
- 5 work upon or in connection with the construction of a building on
- 6 the owner's property for the owner's own use to which employees
- 7 and the public are not generally to have access.
- 8 (d) A person not licensed under this article who is plan-
- 9 ning, designing, or directing the construction of a -residence-
- 10 RESIDENTIAL building not exceeding 3,500 square feet in calcu-
- 11 lated floor area. As used in this subdivision and section
- 12 2014(e), "calculated floor area" means that portion of the total
- 13 gross area, measured to the outside surfaces of exterior walls
- 14 intended to be habitable, including a heater or utility room, but
- 15 not including a crawl space; an unfinished and nonhabitable por-
- 16 tion of a basement or attic; or a garage, open porch, balcony,
- 17 terrace, or court.
- 18 (E) A PERSON NOT LICENSED UNDER THIS ARTICLE WHO IS PLAN-
- 19 NING, DESIGNING, OR DIRECTING THE CONSTRUCTION OF A SINGLE-FAMILY
- 20 RESIDENTIAL BUILDING THAT IS TO BE BUILT UNDER A PERMIT ISSUED TO
- 21 A LICENSED RESIDENTIAL BUILDER AS THAT TERM IS DEFINED IN SECTION
- 22 2401.
- (F) (e) A person who is licensed to engage in the practice
- 24 of architecture, professional engineering, or professional sur-
- 25 veying in another state while temporarily in this state to
- 26 present a proposal for services.
