

## SENATE BILL No. 564

April 1, 1993, Introduced by Senator SCHWARZ and referred to the Committee on State Affairs and Military Veterans Affairs.

A bill to amend the title of Act No. 8 of the Public Acts of the Extra Session of 1933, entitled as amended
"The Michigan liquor control act,"
as amended, being sections 436.1 to 436.58 of the Michigan
Compiled Laws; to add section 28d; and to repeal certain parts of the act on a specific date.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. The title of Act No. 8 of the Public Acts of the
- 2 Extra Session of 1933, as amended, being sections 436.1 to 436.58
- 3 of the Michigan Compiled Laws, is amended and section 28d is
- 4 added to read as follows:
- 5 TITLE
- An act to create a liquor control commission for the control
- 7 of the alcoholic beverage traffic within the state of Michigan,
- 8 and to prescribe its powers, duties and limitations; to provide

- 1 for the control of the alcoholic liquor traffic within the state
- 2 of Michigan and the establishment of state liquor stores; to pro-
- 3 vide for the care and treatment of alcoholics; to provide for the
- 4 incorporation of farmer cooperative wineries and the granting of
- 5 certain rights and privileges thereto; to provide for the licens-
- 6 ing and taxation thereof, and the disposition of the moneys
- 7 received under this act; to prescribe liability for retail
- 8 licensees under certain circumstances; to require security for
- 9 that liability; to provide procedures, defenses, and remedies
- 10 regarding violations of this act; to provide for the enforcement
- 11 and to prescribe penalties for violations of this act; to provide
- 12 for the confiscation and disposition of property seized under the
- 13 provisions of this act; to provide a referendum in certain cases;
- 14 -and to repeal certain acts and parts of acts; AND TO REPEAL
- 15 CERTAIN PARTS OF THIS ACT ON A SPECIFIC DATE.
- 16 SEC. 28D. (1) THE COMMISSION SHALL NOT PROHIBIT THE HOLDER
- 17 OF A SPECIALLY DESIGNATED DISTRIBUTOR OR A SPECIALLY DESIGNATED
- 18 MERCHANT LICENSE THAT HAS A DRIVE-THROUGH OPERATION FROM TRANS-
- 19 FERRING THE LOCATION OF THE LICENSED PREMISES IF THE FOLLOWING
- 20 CONDITIONS ARE MET:
- 21 (A) THE AREA FROM WHICH THE LICENSED PREMISES ARE TO BE
- 22 TRANSFERRED IS BEING REDEVELOPED OR RENOVATED BY A DOWNTOWN
- 23 DEVELOPMENT AUTHORITY.
- 24 (B) THE GOVERNMENTAL UNIT TO WHICH THE LICENSED PREMISES ARE
- 25 TO BE TRANSFERRED APPROVES OF THE PROPOSED LOCATION.
- 26 (2) THIS SECTION IS REPEALED EFFECTIVE APRIL 1, 1995.
