

SENATE BILL No. 623

May 6, 1993, Introduced by Senators HOFFMAN, CISKY and GOUGEON and referred to the Committee on Transportation and Tourism.

A bill to amend Act No. 300 of the Public Acts of 1949, entitled as amended

"Michigan vehicle code,"

as amended, being sections 257.1 to 257.923 of the Michigan Compiled Laws, by adding section 708c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 300 of the Public Acts of 1949, as
- 2 amended, being sections 257.1 to 257.923 of the Michigan Compiled
- 3 Laws, is amended by adding section 708c to read as follows:
- 4 SEC. 708C. (1) A PERSON SHALL NOT EQUIP A MOTOR VEHICLE
- 5 THAT IS TO BE USED UPON THE HIGHWAYS OF THIS STATE WITH OR OPER-
- 6 ATE A MOTOR VEHICLE UPON THE HIGHWAYS OF THIS STATE THAT IS
- 7 EQUIPPED WITH A DEVICE DESIGNED FOR THE PURPOSE OF, OR CAPABLE
- 8 OF, JAMMING OR DISTORTING SIGNALS EMITTED BY A RADAR SPEED
- 9 DETECTION DEVICE.

- 1 (2) THIS SECTION DOES NOT APPLY TO A DEVICE DESIGNED FOR THE
- 2 PURPOSE OF, OR CAPABLE OF, JAMMING OR DISTORTING SIGNALS EMITTED
- 3 BY A RADAR SPEED DETECTION DEVICE, IF EITHER OF THE FOLLOWING
- 4 APPLIES:
- 5 (A) THE DEVICE OR USE OF THE DEVICE IS LICENSED BY A FEDERAL
- 6 OR STATE AGENCY.
- 7 (B) THE DEVICE IS OWNED OR OPERATED BY A FEDERAL OR STATE
- 8 AGENCY OR AN AGENCY OF A LOCAL UNIT OF GOVERNMENT AND IS USED BY
- 9 THE AGENCY'S EMPLOYEES IN PERFORMING THEIR OFFICIAL DUTIES.
- 10 (3) A DEVICE THAT IS USED TO VIOLATE THIS SECTION IS SUBJECT
- 11 TO SEIZURE AND FORFEITURE UNDER CHAPTER 47 OF THE REVISED JUDICA-
- 12 TURE ACT OF 1961, ACT NO. 236 OF THE PUBLIC ACTS OF 1961, BEING
- 13 SECTIONS 600.4701 TO 600.4709 OF THE MICHIGAN COMPILED LAWS.
- 14 Section 2. This amendatory act shall not take effect unless
- 15 Senate Bill No. ____ or House Bill No. ____ (request
- 16 no. 01557'93a) of the 87th Legislature is enacted into law.
